ORDER

WHEREAS THE ANANDBA MAHILA ADHYAPAN MAHAVIDYALAYA, KARAI GAAM ROAD, NAANA CHILODA OCTROI NAKA, AT & PO - VALAD, GANDHINAGAR GUJARAT (Code No-APW00413/322016) has granted Recognition/Permission to run P.T.C. course by WRC, NCTE for four units vide letter recognition order (1) No.WRC/5-6/40/2002/05961 dt. 30.09.2002 (one unit), (2) No.WRC/2-32/62/2004/4949 dt. 03.08.2004 (one unit) and (3) No.WRC/2-32/322016/72/2005/4124 dt. 13.05.2005 (two unit).

2. AND WHEREAS, Institution vide its letter dt. 27.03.2010 requested to withdraw recognition of two units of P.T.C. course from four units.

3. AND WHEREAS, WRC considered the letter received from Managing Trustee, the ANANDBA MAHILA ADHYAPAN MAHAVIDYALAYA, KARAI GAAM ROAD, NAANA CHILODA OCTROI NAKA, AT & PO - VALAD, GANDHINAGAR GUJARAT, in its 133rd meeting and resolved that **withdrawal of two units of the P.T.C. from four units permitted as requested by the institution.**

NOW THEREFORE, In exercise of the power vested under section 17 of NCTE Act, 1993 the recognition granted to ANANDBA MAHILA ADHYAPAN MAHAVIDYALAYA, KARAI GAAM ROAD, NAANA CHILODA OCTROI NAKA, AT & PO - VALAD, GANDHINAGAR GUJARAT for P.T.C. course vide order No.WRC/2-32/322016/72/2005/4124 dt. 13.05.2005 (granted for two units) is hereby withdrawn on the request of institution from the end of the academic session next following the date of issue of this order.
