Withdrawal Order U/S-17 680, 681, 682

Whereas, recognition was granted to the institution, namely, VIDYAWATI CHATURVEDI SHIKSHA MAHAVIDYALAYA, TORIA HOUSE, JAWAHAR MARG, DISTRICT.- CHHATTARPUR, MADHYA PRADESH (APW05726/223621) for B.Ed. Course 100 Intake vide order dated 12.09.2008.

AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 20.01.2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 27.05.2015.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 15.09.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE HQRs. to the institution on 12.02.2016 and the reply of Deficiency Letter was received in NCTE HQRs. on 14.03.2016.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 12.01.2016.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in 255th Meeting held on June 22-24, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, it has been found from the record that the Institution has not submitted the following documents in compliance of the conditions mentioned in the revised order.

1. Original Staff Profile for the session 2015-16 duly approved by the affiliating body.
2. Originally Notarized CLU, NEC, Building Plan and Building Completion Certificate.

AND, WHEREAS, the Show Cause Notice was issued on 30.11.2016 in compliance of regulation 2014 and the reply of SCN was not received.

AND WHEREAS, the matter was placed in 280th Meeting held on August 31st - September 01st, 2017 of WRC and the Committee decided that "... Show Cause Notice was issued to the institution on 30.11.2016 regarding approved staff list, FDRs, Building Completion Certificate and CLU. The institute has not given any reply till date.

Hence, Recognition is withdrawn from the session 2018-2019.



Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
