RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, VIDYAWATI CHATURVEDI SHIKSHA MAHAVIDYALAYA, RUN BY-PRIYAVRAT MAHILA UTTIHAN SAMITI, HOUSE NO.-38,40, WARD NO.-33, KHASRA NO. 3102, SARASWATI NAGAR, PANNA ROAD, CHHATTARPUR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 12.09.2008 for an annual intake of 100 students.

AND WHEREAS, one Shri Pawan Dubey had filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court had directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since, the institutions are existing institutions, the inspection was to be conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 20.01.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 28.08.2015.

AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 30.11.2016 and reply of compliance show cause notice not submitted.

AND WHEREAS, the matter was placed in 280th Meeting held on August 31 September 01, 2017 of WRC and the Committee decided that "...Show Cause Notice was issued to the institution on 30.11.2016 regarding approved staff list, FDRs, Building Completion Certificate and CLU. The institute has not given any reply till date.

Hence, Recognition is withdrawn from the session 2018-2019. FDR, if any, be returned."

AND WHEREAS, the Withdrawal Order issued on 19.09.2017. The institution filed a appeal to the appellate authority Hqrs. no. APPL12023 dated 31.10.2017. Regulatory file sent to Hqrs. on 01.12.2017.

AND WHEREAS, the appeal order dated 13.02.2018 the council hereby remands back the case of Vidyawati Chaturvedi Shiksha Mahavidyalaya, chhatarpur, Madhya Pradesh, to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 292nd Meeting held on May 15 - 17, 2018 of WRC and the Committee decided that "...This is a case of appeal. Appellate Authority vide order dated 13.02.2018 has remanded the case to WRC. The examination of the case shows that the institution has submitted a list of 1 Principal and 12 faculty members. The list is not approved by the Registrar and not in original. The institution is required to send the staff profile approved by the Registrar in original. Attention is drawn to Appendix-IV of NCTE Regulations, 2014 regarding requirement of staff

FDRs for Rs.12.00 lakhs in joint account not submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the clarification letter issued on 21.05.2018 and reply of clarification received on 28.05.2018.

AND WHEREAS, the matter was placed in 293rd Meeting held on June 12-14, 2018 of WRC and the Committee decided that "...The case file was seen. This is a case of Appeal. The Appeal Committee vide order dated 03.03.2018 remanded the case to WRC. Thereafter, compliance letter was issued to the institution on 21.05.2018 regarding staff profile of 1:15 (excluding Librarian). However, it is seen that faculty members at Sr. Nos. 8 & 11 do not have the required percentage in PG. The institute needs to appoint two more faculty members in lieu of above.

Hence, Clarification be issued to the institution for the appointment of two lecturers within one month failing which the no. of units will be reduced to one."


AND WHEREAS, the clarification letter issued on 29.06.2018 and reply of clarification received on 25.06.2018.

AND WHEREAS, the matter was placed in 294th Meeting held on July 04 - 05, 2018 of WRC and the Committee decided that "...Consequent to the appeal order, clarification letter dated 29.06.2018 was issued to the institution regarding the appointment of two lecturers. The institution has appointed two additional staff but they do not have the required NET qualification as per NCTE notification published on 09.06.2017.

Hence, Recognition is restored but with one unit."

NOW THEREFORE, the recognition of VIDYAWATI CHATURVEDI SHIKSHA MAHAVIDYALAYA, RUN BY-PRIYAVRAT MAHILA UTTIHAN SAMITI, HOUSE NO.-38,40, WARD NO.-33, KHASRA NO. 3402, SARASWATI NAGAR, PANNA ROAD, CHHATTARPUR, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 50 students (one basic units of 50 students) is herby revived.


