Withdrawal Order U/S-17 479, 480

WHEREAS, recognition was granted to the institution, namely, **DIGNITY COLLEGE RUN BY SHRI SIYAWAR SHIKSHA SAMITI, KHASARA NO. - 104/2, PLOT NO. - 18, MAIN ROAD, VILLAGE - MOJA - KEOLARI, KESLI, P.O. + TEHSIL - KESLI, DIST. - SAGAR, - 470235, MADHYA PRADESH** had submitted the application on **29.12.2012** to Western Regional Committee of the NCTE for grant of recognition for **B.ED. (CO-ED)** Course with an annual intake of 100 students

AND WHEREAS, the Hard copy of the application was received on **09.01.2013** and the application was processed.

AND WHEREAS, the Deficiency Letter was issued on **05.08.2013** and the reply of Deficiency Letter was received on **03.10.2013**.

AND, WHEREAS, the matter was placed before the WRC in its **190th Meeting held on September 18-20, 2013** of WRC and the Committee decided that "... The cases where replies of the deficiency letters from the institution have been received and the required documents are in order, the Regional Director will constitute VT for inspection. After constituting the VTs, the status of the cases will be submitted for perusal of the Committee."

AND, WHEREAS, the Inspection letter was sent to the Institution & VT members on **18.12.2013**, inspection conducted by VT members on **28.12.2013** and the VT report/letter received in WRO on **31.12.2013**.


AND, WHEREAS, the matter was placed before the WRC in its **198th Meeting held on January 09-11, 2014** of WRC and the Committee decided that "...The case file and the VTR were perused and the CD was seen. The CD shows sufficient building with sufficient physical and academic infrastructure. The VT has recommended the case.

Hence LOI under Clause 7(9) of NCTE Regulations, 2009, be issued. The formalities required after issue of LOI are as follows:-

- (i) Appointment of the requisite faculty or staff as per the provisions of Sub-Regulation (9);
- (ii) Submission of staff list approved by the concerned affiliating body;
- (iii) Management and the individual affidavits; and
- (iv) FDRs converted in the joint account.

If these formalities are completed well before **03.03.2014**, **Recognition** can be considered for the academic session 2014-2015. Otherwise, the case will be considered for the academic session 2015-2016."

AND, WHEREAS, the LOI was issued to the institution on **22.01.2014** and the reply of LOI was received on **01.03.2014**.

AND, WHEREAS, the matter was placed before the WRC in its 203rd Meeting held on March 02-03, 2014 of WRC and the Committee decided that "...The case file was seen. LOI was issued to the institution on 22.01.2014. The Society submitted the documents required after issue of LOI. The documents are found to be in order.

Hence, Recognition is granted from the academic session 2014-2015 under Clause 7(11) of NCTE Regulations, 2009."

AND, WHEREAS, Recognition Order was issued to the institution vide order No. WRC/5-6/WRCAPP2341/223/203rd/MP/2013/116204-11 dated 03.03.2014.

AND, WHEREAS, the Affidavit Regarding Acceptance and Compliance of NCTE Regulations, 2014 was issued to the institution on 14.01.2015 and the reply was received on 12.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (50 students each) to the institution on 20.05.2015.

AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND, WHEREAS, a Show cause notice of compliance was issued to institution on 20.02.2017 and the reply of Show cause notice was received on 23.03.2017.

AND WHEREAS, the matter was placed in 285th Meeting held on December 19-21, 2017 of WRC and the Committee decided that "... In response to the Show Cause Notice dated 20.02.2017, the institution has not submitted approved staff profile.

FDRs of Rs.4.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs if any, be returned."

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
