ORDER

WHEREAS, recognition was granted to the institution, namely, DIGNITY COLLEGE RUN BY SHRI SIYAWAR SHIKSHA SAMITI KH. NO.- 104/2, PLOT NO.- 18, MAIN ROAD, VILL- MOJA-KEOLARI, KESLI, P.O +TEH- KESLI, SAGAR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course (100 Intake) vide order dated 03.03.2014.

2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015 and the reply was received on 12-01-2015.

3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 20.05.2015.

4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, a Show cause notice was issued to the institution on 20.02.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 23.03.2017. The matter was placed in 285th Meeting of WRC held on December 19-21, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 20.02.2017, the institution has not submitted approved staff profile.

FDRs of Rs.4.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn. FDRs if any, be returned."

7. AND, WHEREAS, the withdrawal order was issued to the institution on 08.01.2018 and the institution filed an appeal at NCTE, Hqrs. on 09.03.2018. The appeal order dated 27.03.2019 the Council hereby remands back the case to the WRC, NCTE for necessary action. The reply was submitted by the institution on 24.04.2019 as per direction appeal order.

8. AND WHEREAS, the matter was placed in 310th Meeting held on August 19th - 21st, 2019 of WRC and the Committee decided that "...This is the case of appeal. The appellant authority vide letter dated 27/03/2019 remanded back the case to WRC.

On perusal of the reply of the institution vide letter dated 24/04/2019. The institution has submitted original Staff profile of 1+15 qualified staff approved by the affiliating body along with the letter of granting approval & FDRs Rs. 7+5 lakhs.

Hence, the committee decided to restore the recognition of two basic units of B.Ed. programme (total 100 students)."
