**ORDER**

AND WHEREAS, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to **BHAGWANT COLLEGE OF EDUCATION, NEAR VILLAGE - CHACHIYAWAS, SIKAR ROAD, AJMER, RAJATHAN** for conducting **B.Ed. Course** of SECONDARY (level) of one year duration with an annual intake of 100 (ONE HUNDRED) students from the academic session 2009-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 vide this order NCTE/RJ-1044/2008/64300-64306 dated 30.9.2008

AND WHERE AS, the university vide letter dated 22.4.2009 requested that Bhagwant College of Education, Ajmer with 100 seat for B.Ed. programme may granted approval for affiliation with Bhagwant University. Matter was considered in NRC in its 140<sup>th</sup> Meeting held on 25<sup>th</sup> -26<sup>th</sup> April 2009 taking consideration the fact that Bhagwant College of Education, near Village - Chachiyawas, Sikar Road, Ajmer, Rajasthan has, hence, been granted the status of a University by State legislature, the B.Ed. course recognized by NRC at **Bhagwant College of Education may be treated to have been affiliated to Bhagwant University, Ajmer.** Previous affiliating University ( M.D.S. University, Ajmer ) has also issued a NOC letter No. F 13/Acad-11/MDSU/2009/19960 dated 24.4.2009 to this effect.
