**WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution ANSHI COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHOGANJ, LASHKAR, MADHYA PRADESH for D.ED. Course vide order dated 30.10.2006 with an annual intake of 50 students.

AND WHEREAS, the recognition of the institution was withdrawn by WRC vide order dated 17.04.2010.

AND WHEREAS, the institution preferred an appeal against the withdrawal order and the Council vide order dt. 22.09.2010 reversed the WRC's order dated 17.04.2010 with the direction to WRC for taking appropriate decision after getting composite inspection of the institution for the all recognized teacher training programmes and for further decision thereafter.

AND WHEREAS, the copy of the appeal order passed by the Council was placed before the WRC in its 142<sup>nd</sup> meeting held from November 22-24, 2010 and the Committee decided that VT be constituted for composite inspection.

AND WHEREAS, the inspection of the institution was conducted on 19.07.2011. The VT report and other relevant documents were placed before WRC in its 154<sup>th</sup> meeting held from September 11-12, 2011 and the Committee decided to issue Letter of Intent. Accordingly, Letter of Intent under clause 7(9) of NCTE Regulations, 2009 was issued to the institution on 19.12.2011.

AND WHEREAS, the reply submitted by the institution on 17.02.2012 was placed before WRC in its 163<sup>rd</sup> meeting held from May 22-24, 2012 and the Committee decided that clarification be sought from the institution. Accordingly, letter was issued to the institution on 20.06.2012.

AND WHEREAS, the reply submitted by the institution on 19.07.2012 was placed before WRC in its 167<sup>th</sup> meeting held from July 22-24, 2012 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued to the institution on 04.10.2012.

AND WHEREAS, the reply submitted by the institution on 01.11.2012 was placed before WRC in its 179<sup>th</sup> meeting held from February 11-13, 2013 and the Committee observed that "the institution had been granted recognition on 30.10.2006. Recognition was withdrawn on 17.04.2010. In Appeal Order dated 22.09.2010, the order of the WRC was reversed and composite inspection was ordered. Composite inspection was done on 19.07.2011, after which LOI was issued on 19.12.2011. The institution has not been able to comply with one of the necessary points, after issue of LOI, i.e. appointment of Principal having five years of teaching in primary or elementary teacher education, even though it has been given two opportunities for the same. Hence, Recognition is withdrawn on the above points from the end of the academic session next to the date of issue of withdrawal order."

NOW THEREFORE, recognition granted to ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHOGANJ, LASHKAR, MADHYA PRADESH for D.Ed. course vide order dated 30.10.2006 is hereby withdrawn in terms of section 17(1) of the NCTE Act, 1993, on the above ground from the end of the academic session next following the date of withdrawal order.
