ORDER

WHEREAS, the recognition was granted to the Institution **ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHOGANJ, LASHKAR, MADHYA PRADESH** for **D.ED.** Course vide order dated **30.10.2006** with an annual intake of **50** students.

AND WHEREAS, the recognition of the institution was withdrawn by WRC vide order dated 17.04.2010.

AND WHEREAS, the institution preferred an appeal against the withdrawal order and the Council vide order dt. 22.09.2010 reversed the WRC's order dated 17.04.2010 with the direction to WRC for taking appropriate decision after getting composite inspection of the institution for the all recognized teacher training programmes and for further decision thereafter.

AND WHEREAS, the copy of the appeal order passed by the Council was placed before the WRC in its 142nd meeting held from November 22-24, 2010 and the Committee decided that VT be constituted for composite inspection.

AND WHEREAS, the inspection of the institution was conducted on 19.07.2011. The VT report and other relevant documents were placed before WRC in its 154th meeting held from September 11-12, 2011 and the Committee decided to issue Letter of Intent. Accordingly, Letter of Intent under clause 7(9) of NCTE Regulations, 2009 was issued to the institution on 19.12.2011.

AND WHEREAS, the reply submitted by the institution on 17.02.2012 was placed before WRC in its 163rd meeting held from May 22-24, 2012 and the Committee decided that clarification be sought from the institution. Accordingly, letter was issued to the institution on 20.06.2012.

AND WHEREAS, the reply submitted by the institution on 19.07.2012 was placed before WRC in its 167th meeting held from July 22-24, 2012 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued to the institution on 04.10.2012.

AND WHEREAS, the reply submitted by the institution on 01.11.2012 was placed before WRC in its 179th meeting held from February 11-13, 2013 and the Committee decided that withdrawal order issued to the institution. Accordingly, withdrawal order was issued to the institution on 21.02.2013.

AND WHEREAS, the institution had preferred an appeal under Section 18 of the NCTE Act 1993, before the Council against the aforesaid order and the Appellate Authority vide order dated 26.08.2013 remanded the case to WRC with the direction that the appellant may be given a period of one month time from the date of issue of this order to appoint the Principal who is fully qualified as per the norms and report the same to the WRC, Bhopal and the NCTE. In case he fails to do so, the WRC may reiterate the earlier order of withdrawal.

AND WHEREAS, the aforesaid appeal order was placed in the 192nd meeting held from October 30-31, 2013 and the Committee decided that clarification be sought from the institution. Accordingly, clarification letter was issued to the institution on 13.11.2013.

AND WHEREAS, the reply submitted by the institution on 26.11.2013 was placed before WRC in its 201st meeting held from February 19-22, 2014 and the Committee observed that "Against the withdrawal order dated 21.02.2013, the institution had approached the Appellate Authority. The Appellate Authority remanded the case to WRC, giving one month's time from the appeal order dated 26.08.2013, to the institution to appoint a properly qualified Principal. This has been done by the Society, thus Recognition of the institution stands. Hence, no further action is called for."

NOW THEREFORE, the recognition granted to ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHOGANJ, LASHKAR, MADHYA PRADESH for conducting D.Ed. course with an annual intake of 50 seats stands.
