ORDER

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 10.09.2016.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 287th Meeting held on January 30-31, 2017. The Committee decided that "...Show Cause Notice was issued to the institution on 20.11.2017 regarding the shifting of the college to the area where the Academy of Nursing Science and Hospital was situated. The management has clarified that the building where the College of Education is situated will not be used by the Academy of Nursing Science and Hospital. Therefore, shifting is permitted."
