SHIFTING ORDER

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHEGANJ, LASHKAR GWALIOR-474001, MADHYA PRADESH for B.Ed. course vide order dated 27.06.2005 for an annual intake of 100 seats. Revised order for two basic units of 50 students each (100 students) was issued on 31.05.2015.

AND WHEREAS, the institution applied under clause 8 (11) of NCTE Regulations 2009, for change of premises from ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHEGANJ, LASHKAR GWALIOR-474001, MADHYA PRADESH to ANSH COLLEGE OF EDUCATION, ARYAN 01 KM STONE, NEAR NAI DUNIA PRESS, SHIVPURI LINK PIPROLI, ROAD, KEDARPUR, GWALIOR, MADHYA PRADESH.

AND WHEREAS, the inspection letter was issued to the VT members & institution online on 06/09/2016 and the inspection was conducted in its new premises of the institution on 10-09-2016. VT inspection report received in WRC on 16.09.2016 with Damaged CD.

AND WHEREAS, the visiting team report alongwith other documents was placed in 259<sup>th</sup> Meeting of WRC held on September 21-23, 2016 and the Committee observed that "...A Letter seeking Clarification was sent to the institution on 26/08/2016 and reply was received 06/09/2016. The points of the reply are as under:

- i) FDRs : All the FDRs required are in the file.

Hence, no further action is required.

The VT for shifting was also constituted on 10/09/2016 and Report was received subsequently. However, the CD was received in a damaged condition.

Hence, the institution be asked to submit a fresh CD."

AND WHEREAS, the No Further Action letter and be asked to submit a fresh CD was issued to the institution on 29.09.2016 and reply received on 06.10.2016.

AND WHEREAS, the matter was placed in 283<sup>rd</sup> Meeting of WRC held on November 14-15, 2017 and the Committee observed that "...This is a case of shifting. VT report was perused and the CD was seen. The CD shows a building with adequate infrastructural and instructional facilities.

It has also been learned that the building earmarked for Ansh College of Education is also 'The Academy of Nursing Science and Hospital'. It may be clarified if the proposed shifting is to this institution of 'The Academy of Nursing Science and Hospital'. If so, the latest Building Completion Certificate, ear marking of built-up area of 3500 sq.mts. for the teacher education courses and the latest staff profile duly approved by the affiliating body be submitted for further processing of case.

Hence, Show Cause Notice be issued on the above points. Reply should be submitted within one month."


AND WHEREAS, the Show Cause Notice was to the institution on 17.11.2017 and reply received on 022.12.2017.

AND WHEREAS, the matter was placed in 287<sup>th</sup> Meeting of WRC held on January 30-31, 2018 and the Committee observed that "...Show Cause Notice was issued to the institution on 17.11.2017 regarding the shifting of the college to the area where the Academy of Nursing Science and Hospital was situated. The management has clarified that the building where the College of Education is situated will not be used by the Academy of Nursing Science and Hospital.

**"Therefore, shifting is permitted."**

NOW THEREFORE, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, the permission under clause 8(9) of NCTE Regulations, 2014, is hereby granted for change of premises from ANSH COLLEGE OF EDUCATION, KADAM SAHABH KI KOTHI, KADAM SAHABH KA BADA, MAMA KA BAZAR, MADHEGANJ, LASHKAR GWALIOR-474001, MADHYA PRADESH to ANSH COLLEGE OF EDUCATION, ARYAN 01 KM STONE, NEAR NAI DUNIA PRESS, SHIVPURI LINK PIPROLI, ROAD, KEDARPUR, GWALIOR, MADHYA PRADESH for conducting B.Ed. & D.El.Ed. course with immediate effect.
