Withdrawal Order

Whereas, the recognition was granted to the institution namely SARASWATI SHIKSHA MAHAVIDYALAYA, RUN BY- SARASWATI SHISHU MANDIR SAMITI, RISHI NAGAR, UJJAIN-456010, MADHYA PRADESH (APW5865/223637) for B.Ed. Course vide order dated 28.08.2008.

AND WHEREAS, the Western Regional Committee received copies of inspection reports of inspections conducted in the B.Ed. institutions by the District Authority, at the behest of the Higher Education Department, Govt. of Madhya Pradesh.

AND WHEREAS, the matter was placed in the 162nd WRC Meeting held on May 10, 2012 and it was decided to issue show cause notice to the institution based on the points given in the report of the Higher Education Department, which are as follows :-

- अधोसंरचना - प्रयोगशालाएँ 03
खेल मैदान तथा मल्टीपरपस हॉल समिति द्वारा संचालित महाविद्यालय के साथ साझा है। समिति द्वारा संचालित अन्य विद्यालयों के साथ साझा हैं
- स्टाफ अशैक्षणिक स्टाफ - केवल 02 तकनीशियन कार्यरत हैं।
- मान्यताएँ - कमियाँ - निरंक
- वेतन भत्ते - समिति द्वारा तय है।
यूजीसी/ एनसीटीई के नियमों के तहत नहीं है।

And whereas, in compliance of show cause notice dated 05.12.2012 written representation submit by the institution on 03.01.2013.

AND WHEREAS, the institution submitted reply dated 27.11.2012, and the matter was placed before WRC in its 199th Meeting held on 20th - 22nd, January, 2014 and the Committee decided to withdraw the recognition on the following points :-

“Show Cause Notice dated 05.12.2012 was issued to the institution on the basis of the inspection reports of the Higher Education Department, Government of Madhya Pradesh and other points as per the NCTE Regulations.

The reply of the institution dated 28.12.2012 was examined. The institution has informed that it has provided the laboratories as required under the NCTE norms, and the technicians also have been appointed as per norms. The institution has also informed that it is paying salary to the staff as fixed by the Fee Structure Committee.

It is seen that the institution has provided a Building Completion Certificate. However the institution has not provided the staff list approved by the affiliating body, nor has it mentioned anything about the appointment of the teaching staff in its reply. The NCTE norms are silent as regards technicians whom the institution claims to have appointed. The institution has not submitted any proof as regards the payment of salary to the teaching staff as per the UGC/State Government scales. No bank statement is provided. No information has been given regarding the Provident Fund which is required as per Clause 10(2) of NCTE Regulations 2009 and 4(V)(d)&(e) of Appendix-4 of Norms and Standards of NCTE Regulations, 2009.

Hence, Recognition is withdrawn from the end of the academic session next to the date of issue of withdrawal order.”
