AND WHEREAS, the visiting team constituted by WRC inspected its new premises on 21.02.2015.

AND WHEREAS, the visiting team report alongwith other documents, videograph was placed in 223rd Meeting of WRC held on April 23-24, 2015 and the Committee observed that "...The institution was inspected U/S 13 for the B.Ed. course the VT report states that the building, infrastructural and instructional facilities are available as per NCTE Norms. The College is situated at Mauja-Piparia, Vikas khand – Bargi, Teh. & Dist. Jabalpur.

On the basis of the inspection report U/S 13 and in view of its positive recommendation, the institute is permitted to shift its premises which has been inspected. The application for shifting has been pending since 2008."
