ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Western Regional Committee grants recognition to **Kesarvani Mahavidyalaya, Jabalpur** for B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 60 students subject to fulfilling the following conditions:

1. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
2. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
3. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
4. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
5. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
6. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
7. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
8. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 7 above.

If Kesarwani Mahavidyalaya, Jabalpur contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.

Formal Order

1. This letter is in continuation to NCTE/WRC office recognition order no. WRC/2-32/213029/82/2005/24870(2470)(A) dated on 10/03/06.
2. WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 KESARWANI MAHAVIDYALAYA, GOLE BAZAR, GARHA PATHAK ROAD, JABALPUR-488002, MADHYA PRADESH has submitted an application (Code No.- APW01959/213029 (Revision)) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting B.ED. course with revision of intake from 60 to 100 students on 30-12-2004 .
3. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith , the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the SEC teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources. laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
4. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to KESARWANI MAHAVIDYALAYA, GOLE BAZAR, GARHA PATHAK ROAD, JABALPUR-488002, MADHYA PRADESH for conducting B.ED. course of SEC of 1 year duration with revision of intake from 60 to 100(SEC) from the academic session 2005-2006 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulation 2007.
5. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
7. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
8. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
9. Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC , affiliating University/Body , the State Government etc, applicable.



10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars.
 - (iii) Staff Profile.
 - (iv) Recognition letter.
 - (v) Information for having fulfilled the norms & standard and other required conditions.
12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
13. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.


