CONTINUED ORDER

WHEREAS, WRC, NCTE had granted recognition permission to the institution namely **GYANODAYA COLLEGE OF EDUCATION, JAISINAGAR, SAGAR- 470001 MADHYA PRADESH** vide order no. NCTE/2006-2007/C-20484-20486 dt. 27.07.2007 & WRC/5-6/99th/2007/C-24811-24817/ dt.28.12.2007 for conducting the **M.Ed. (CO.ED)** course one-year duration with an annual intake of 25 students.

AND WHEREAS, the revised recognition order was issued to **GYANODAYA COLLEGE OF EDUCATION, JAISINAGAR, SAGAR- 470001 MADHYA PRADESH** vide order No. WRC/APW04192/225041/M.P/2015/42325 dt. 31.05.2015 for M.Ed. Programme of two years duration with an annual intake of 50 students (one basic units) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institution which have not submitted compliance.

AND WHEREAS, it has been found from the record that the Institution has not submitted the following documents in compliance of the conditions mentioned in the revised order.

- Staff Profile for the session 2015-16 duly approved by the Affiliating Body.
- Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the Show cause notice was issued to the institution on 06.01.2017 and reply was submitted by the institution 30.01.2017.

AND WHEREAS, the matter was placed in 311th Meeting held on 25th -27th, September 2019 and WRC Committee decided that "... The SCN was issued to the institution on 23/01/2017. The institution has submitted reply on 30/01/2017.

On perusal of the reply of the institution the committee observed that:

- The institution has submitted staff profile.
- The institution is required to submit original staff profile issued by the affiliating body along with original approval letter in original.
- The institution is required to submitted notarised Land use certificate issued by the competent authority.

Hence, the committee decided to confer last opportunity to the institution to submit the above within 30 days failing which recognition will be withdrawn under section 17 of NCTE Act, 1993.

AND WHEREAS, the Compliance letter was issued to the institution on 03.10.2019 and reply was submitted by the institution 29.11.2019.


