**RESTORATION ORDER**

WHEREAS, the recognition was granted to the institution namely **Chindhuji Laxmanrao Purake Shikshan Prasarak Mandal, S.No. 25101, No. 49/1, Khasra No. 85/2, AT. Ralegoan, Maharashtra Yavatmal, Pincode-445001.** For M.Ed. (CO-ED) programme of 1 (one) years duration with an annual intake of 25 students Vide Order No. WRC/5-6/106<sup>th</sup>/2008/40352-40357 dated 28.08.2008.

ANDWHEREAS, the Increase Intake order was issued to the institution for M.Ed. programme for the academic session 2010-2011 with an annual intake of 35 students Vide order No. WRC/APW04776/125070/140<sup>th</sup>/2010/75101-75106 dated: 17.02.2011

5. AND WHEREAS, the matter was considered by WRC in its 416<sup>th</sup> Meeting held on 20<sup>th</sup> to 21<sup>st</sup> March 2025 wherein the Committee decided as under:-

"The matter was considered by WRC in its meeting and as per decision taken by the Western Regional Committee, Show cause Notice to provide reasonable opportunity to submit representation before withdrawal of the above recognition/permission u/s 17 of NCTE Act, 1993 on the ground of non-submission of the PAR for the academic session 2022-23 was issued by the WRC to the institution through online mode on 05.04.2025, a copy of the same was also sent through speed post."

Accordingly, as per the decision of WRC show cause notice was issued vide No. Ref. No. Ref. No. NCTE/2025/WRC/PAR/APW04776/125070 dated.05.04.2025.

6. AND WHEREAS, the matter was considered by WRC in 423<sup>rd</sup> meeting of WRC held on 15 May, 2025 and committee decided as under:-

On careful consideration of the reply/non-submission of reply to the show cause notice(s) of the Teacher Education institutions, NCTE Act 1993, Rules and Regulations, Guidelines issued by NCTE from time to time, the WRC decided that the recognition granted to the institutions for the Programme(s) mentioned against each institution be withdrawn u/s 17 of the NCTE Act, 1993 from the academic session 2025-26.

The institutions are not permitted to make further admissions in the above Teacher Education Programme henceforth w.e.f. 2025-2026.

The WRC further decided that before issue of Withdrawal order, the Regional Director may re-verify that the institutions have not submitted the reply to the Show Cause Notice."

Accordingly, as per the decision of WRC, Withdrawal Order was issued to the institution Vide order No. File No. NCTE/2025/WRC/PAR/ORDER/APW04776/125070/4452-56 dated 16.05.2025.

7. AND WHEREAS, the institution filed an appeal against the Withdrawal order No. File No. NCTE/2025/WRC/PAR/ORDER/APW04776/125070/4452-56 dated 16.05.2025 before NCTE Appellate Authority and NCTE Appellate Authority vide order dated: 13.09.2025 decided as under:

"After perusal of the Appeal Report, documents on record, Appeal Committee of the Council concluded set-aside the impugned order dated 16.05.2025 and remand back the case to Western Regional Committee for fresh consideration in accordance with the directions specified hereinabove. The appellant institution is further directed to forward to the Regional Committee, within fifteen (15) days of receipt of this order, the documents submitted along with the appeal, whereupon the Regional Committee shall take further necessary action strictly in accordance with law and in light of the directions contained herein."

8. AND WHEREAS, The matter was considered by the WRC in its 437<sup>th</sup> (Part-III) meeting held on 03<sup>rd</sup> October, 2025 wherein the Committee decided as under:-

"The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Western Regional Committee and the Committee observed the following: -

- (i) The institution was granted recognition for M.Ed. course of one-year duration with an annual intake of 25 students vide order dated 28.08.2008 and enhanced intake to 35 students vide order dated 17.02.2011.
- (ii) The recognition of the institution was withdrawn by WRC vide Order No. NCTE/2025/WRC/PAR/ORDER/APW04776/125070/4452-56 dated 16.05.2025.
- (iii) The institution filed an appeal under Section 18 of the NCTE Act 1993 before the Council and the Appellate Authority vide its Order dated 13.09.2025 concluded to set aside the impugned order dated 16.05.2025 and remanded back the case to Western Regional Committee for fresh consideration in accordance with the directions to re-examine the submission of PAR by the institution and consider the documentary evidence furnished with the appeal in accordance with the provisions of the NCTE Regulations 2014 and guidelines issued from time to time.



In view of the above, the Committee considered the facts and documents related to the case and decided to restore the recognition granted to the institution for M.Ed of two-year duration. However, the said Institution is also directed to submit the documents provided along with the appeal for scrutiny and verification by the Western Regional Committee, within fifteen (15) days of receipt of the restoration order. The order be issued accordingly."

11. NOW THEREFORE, the Western Regional Committee hereby restores recognition of Chindhuji Laxmanrao Purake Shikshan Prasarak Mandal, S.No. 25101, No. 49/1, Khasra No. 85/2, AT. Ralegoan, Maharashtra Yavatmal, Pincode-445001 for M.Ed. programme 1 year's duration with an annual intake of 35 students.
