

AND WHEREAS, the visiting team report along with other documents was placed in 297th Meeting of WRC held on September 13-14, 2018 and the Committee observed that "...This is a case of shifting. VTR was perused and the CD was seen. The CD shows a good building with adequate infrastructural and instructional facilities. The VT has recommended the case.

Hence, shifting is permitted."
