**Withdrawal Order U/S-17**

WHEREAS, recognition was granted to the institution, namely, RADHA KRISHNA COLLEGE, PLOT NO. 87, 88, 99/2, STREET NO. - NATIONAL HIGHWAY 75, VILLAGE-CHITUWA, POST OFFICE/TEHSIL/ CITY: DATIA, DISTRICT : DATIA-475661, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 24.03.2008.

2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 05-01-2015.

3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

4. AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND WHEREAS, a Show cause notice was issued to the institution on 28.09.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:  
1) Staff Profile for the session 2015-16 duly approved by the affiliating body,  
2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

6. AND WHEREAS, And the reply was not received by the institution & the matter was placed in 268<sup>th</sup> Meeting of WRC held on February 09<sup>th</sup> - 11<sup>th</sup>, 2017 and the Committee decided that "... Show Cause Notice issued for compliance of NCTE Regulations, 2014, is not received till date. The list of 43 institutions was put up for considerations. In these cases, Show Cause Notice be issued to the institutions as to why the number of units in the B.Ed. course, which were given by revised order, should not be reduced / reversed."

7. AND WHEREAS, a Show cause notice was issued to the institution on 15.02.2017 and the reply was not received by the institution till date.

8. AND WHEREAS, the matter was placed in 309<sup>th</sup> Meeting of WRC held on July 23<sup>rd</sup>-26<sup>th</sup>, 2019 and the Committee decided that "...The Show Cause Notice was issued to the institution vide letter dated 15/02/2019. The reply of the Show Cause Notice of the institution has not been received.

**Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."**


9. Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.
