Withdrawal Order U/S-17 1086, 1087

WHEREAS, recognition was granted to the institution, namely, S.R. MAHAVIDHYALAY, PLOT NO. - 623. CHITTORA ROAD, VILLAGE + P.O. - RATWAI, TEHSIL + DIST. - GWALIOR-474006. MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course vide order No. WRC/APP109/223/202nd/B.ED./2014/115937-115946, dated 02.03.2014.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 09.01.2015 and the reply was received on 19.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 30.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."

AND, WHEREAS, a Show cause notice was issued to institution on 02.02.2017 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure. The institution reply was submitted on dated 20.02.2017.

AND WHEREAS, the matter was placed before the WRC in its 285th meeting held on December 19-21, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 02.02.2017, the institution has not submitted approved staff profile and Building Completion Certificate.

FDRs of Rs.4.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs if any, be returned."

Hence, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition of the institution is hereby withdrawal from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.


