RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, TEXAS EDUCATION COLLEGE, PLOT NO. 266/2/1, PIPROLI ROAD, VILL- KEDARPUR, P.O- LASHIKAR, TEH+DIST-GWALIOR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 18.02.2014 for an annual intake of 100 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015 and the reply was received on 05.01.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 25.05.2015.

AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 03.02.2017 and reply of compliance received on 20.02.2017.

AND WHEREAS, the matter was placed in 285th Meeting held on December 19-21, 2017 of WRC and the Committee decided that "...In response to the Show Cause Notice dated 03.02.2017, the institution has not submitted approved staff profile and Building Completion Certificate.

FDRs of Rs.4.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn. FDRs if any, be returned."

AND WHEREAS, the Withdrawal Order issued on 08.01.2018. The institution filed a appeal to the appellate authority Hqrs. no. APPL12139 dated 29.01.2018. Regulatory file sent to Hqrs. on 27.02.2018.

AND WHEREAS, the appeal order dated 05.06.2018 appellant is directed to forward to the W.R.C. all the documents submitted in the appeal within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

The council hereby remands back the case of Texas Education College, Kedarpur, Piprol Road, Gwalior, Madhya Pradesh, to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 294th Meeting held on July 04 - 05, 2018 of WRC and the Committee decided that "... This is a case of appeal. The Appellate Authority vide order dated 05.06.2018 has remanded the case to WRC.

The institution vide letter dated 06.06.2018 has submitted a staff profile of one Principal and 15 faculty members. Building Completion Certificate also has been submitted. However, FDRs for Rs.12.00 lakhs has not been submitted.

Hence, compliance should be submitted by the institution within one month. As soon as the FDRs are received, the WRO will issue the restoration order."
