Withdrawal Order U/S-17 493, 494

WHEREAS, recognition was granted to the institution, namely, TEXAS EDUCATION COLLEGE, PLOT NO. - 266/2/1, PIPROLI RO, VILLAGE - KEDARPUR, P.O. - LASHKAR, TEHSIL + DIST. - GWALIOR MADHYA PRADESH had submitted the application on 31.12.2012 to Western Regional Committee of the NCTE for grant of recognition for B.ED. (CO-ED) Course with an annual intake of 100 students

AND WHEREAS, the Hard copy of the application was received on 11.01.2013 and the application was processed.

AND WHEREAS, the Deficiency Letter was issued on 22.07.2013 and the reply of Deficiency Letter was received on 25.09.2013.

AND, WHEREAS, the matter was placed before the WRC in its 191<sup>st</sup> Meeting held on October 21-23, 2013 of WRC and the Committee decided that "... The Society has submitted the required documents.

**Hence, VT be constituted."**

AND, WHEREAS, the Inspection letter was sent to the Institution & VT members on 28.10.2013, inspection conducted by VT members on 22.11.2013 and the VT report/letter received in WRO on 29.11.2013.

AND, WHEREAS, the matter was placed before the WRC in its 196<sup>th</sup> Meeting held on December 16-17, 2013 of WRC and the Committee decided that "... The case file and the VTR were perused and the CD was seen. The VT has recommended the case. The CD shows a good building and good physical and academic infrastructure.

**Hence LOI under Clause 7(9) of NCTE Regulations, 2009, be issued."**

AND, WHEREAS, the LOI was issued to the institution on 24.12.2013 and the reply of LOI was received on 04.02.2014.

AND, WHEREAS, the matter was placed before the WRC in its 200<sup>th</sup> Meeting held on February 05-07, 2014 of WRC and the Committee decided that "... carefully. LOI dated 24.12.2013 was issued to the institution. The institution has completed all the formalities required after issue of LOI.

**Hence, Recognition is granted from the academic session 2014-2015 under Clause 7(11) of NCTE Regulations, 2009."**

AND, WHEREAS, Recognition Order was issued to the institution vide order No. WRC/APP16/223/APW07315/222411/200<sup>th</sup>/2014/114798-114805 dated 18.02.2014.

AND, WHEREAS, the Affidavit Regarding Acceptance and Compliance of NCTE Regulations, 2014 was issued to the institution on 14.01.2015 and the reply was received on 05.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (50 students each) to the institution on **25.05.2015**.

AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its **255<sup>th</sup> meeting held on 22-24 June, 2016** and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND, WHEREAS, Show Cause Notice of compliance was issued to the institution on **03.02.2017**, and the reply was received on **20.02.2017**.

AND WHEREAS, NCTE Hqrs. vide letter No.NCTE-Insp 011/246/2017-Insp Section HQ dated 15.09.2017 forwarded a first list of TEIs pertaining to WRC for issuing Show Cause Notice prior to withdrawal of recognition u/s 17 of the NCTE, 1993 for violating the request for filing necessary details as required by the NCTE Headquarters under powers vested as per Regulation 8(12) of Regulations, 2014.

AND WHEREAS, the aforesaid letter was placed before WRC in the 281<sup>st</sup> meeting held on September 19-20, 2017 and it was decided as follows:- "...In order to systematize the compilation of complete information of all TEPs in the country, the NCTE Hqrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017.

NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard to the address as well as duplication of entries for placing the list to WRC for initiating the process of de-recognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the Hqrs as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be de-recognized"

Further directed by the chairperson WRC, the reply of such notices should be issued on or before **6<sup>th</sup> November, 2017**, for the 2<sup>nd</sup> list received from NCTE Hq, after which further necessary action will be taken as per the Regulations.

AND WHEREAS, the Show Cause Notice was issued to the institution on 06.10.2017 and Reply received on 08.11.2017.

AND WHEREAS, the matter was placed in **285<sup>th</sup> Meeting held on December 19-21, 2017** of WRC and the Committee decided that "...The case file was seen. In response to the Show Cause Notice dated 03.02.2017, the institution has not submitted approved staff profile and Building Completion Certificate.

FDRs of Rs.4.00 lakhs (in joint name) not submitted in original.

**Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs if any, be returned."**

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.


