### Recognition Order

WHEREAS in terms of Section 14 (3) (a) of the NCTE Act, 1993, recognition was granted by WRC to **H.L. AND WHEREAS in its 115<sup>th</sup> meeting held on **March ,21-23 ,2009** the Western Regional Committee after considering the report of the visiting team as well as other relevant material furnished by the applicant institution decided to withdrawal recognition on the said institution for **B.ED** course under section 17 (1) of NCTE Act, 1993 and accordingly the Refusal (Modified as withdrawal) Order No. **NCTE/WRC/MP/ APW01973/223398/2009/53777** dated **13/04/2009** was issued to the institution.

3 AND WAHEREAS the correspondent, **H.L. AGRAWAL COLLEGE OF EDUCATION,, NEAR CANARA BANK, WARD NO.27, SHIVAJI NAGAR, ITARSI, HOSHANGABAD 461111 MADHYA PRADESH** has preferred an appeal to NCTE New Delhi under section 18 of the NCTE Act, 1993 against the said Refusal (Modified as withdrawal) order dated **13/04/2009**.

4. AND WHEREAS Council passed an order No. **F.No.89-271/2009/Appeal** dated **13.08.2009** in the appeal filed by the institution and set aside the order of WRC dated **13/04/2009** with direction to WRC to restore the recognition of the institution immediately.

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, and as per the NCTE, New Delhi Order No **.F.No.89-269/2009/Appeal** dated **13.08.2009** the Western Regional Committee hereby restore recognition / permission granted to **H.L. AGRAWAL COLLEGE OF EDUCATION,, NEAR CANARA BANK, WARD NO.27, SHIVAJI NAGAR, ITARSI, HOSHANGABAD 461111 MADHYA PRADESH** vide order No. . **WRC/2-32/223398/77 (CON)/2005/7684** dated **26/09/2005** for conducting **B.ED** course of 1 year duration with an annual intake of 100 seats under clause 7 (11) of NCTE (Recognition Norms & Procedure) Regulation 2007.
