ORDER OF CLOSURE

WHEREAS, WRC, NCTE has granted the recognition/permission under section 14(3)(a)/15(3)(a) of the NCTE Act 1993 to the institution namely SHRI BHAIKAVANNATH SHIKSHAN PRASARAK MANDAL, SHIVAJIRAO ADHALRAO PATIL D.ED. GIRLS COLLEGE, A/P MANCHAR, TA. AMBEGAON, DIST. PUNE-410503 MAHARASHTRA for conducting the D.ED.(M)(GIRLS) course of two-year(s) duration with an annual intake of 50 students vide order no. WRC/5-6/103rd/2008/34271 dated: 13/05/2008.

2. AND WHEREAS, the Society/Trust/institution SHRI BHAIKAVANNATH SHIKSHAN PRASARAK MANDAL, SHIVAJIRAO ADHALRAO PATIL D.ED. GIRLS COLLEGE, A/P MANCHAR, TA. AMBEGAON, DIST. PUNE-410503, MAHARASHTRA the Society/Trust/institution has submitted a request for closing the D.Ed. course vide its letter dated: 10/07/2017.

3. AND WHEREAS, the letter dated 13/09/2017 & 17.05.2018 was sent to the society/institution requesting to send certain documents to WRC. No reply has been received from the institution/society.

4. AND WHEREAS, the matter was placed before WRC in its 313th meeting held on 25th - 27th February 2020, and the Committee decided as under:-

"On perusal of the file of the institution and request for the closure of the programme by the institute / Management, the Committee resolved to accede to the request of the management / institution and decided that the recognition granted to the institution be withdrawn from the end of the academic session and withdrawal order be issued.

Further, the FDRs towards Endowment and Reserve fund, available with NCTE, may be returned / permitted to be encashed only after submission of the following documents :-

- Resolution of the Society for closure of the programme.
- NOC from the affiliating body as well as from the State Government for closure of the programme."

5. Now therefore, as per the decision of WRC, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993 as amended time to time the Western Regional Committee hereby withdraws recognition of SHRI BHAIKAVANNATH SHIKSHAN PRASARAK MANDAL, SHIVAJIRAO ADHALRAO PATIL D.ED. GIRLS COLLEGE, A/P MANCHAR, TA. AMBEGAON, DIST. PUNE-410503 MAHARASHTRA granted for conducting D.Ed.(M)(GIRLS) course acceding to the request for closure made by the Society/Trust/Institution from the end of the academic session next following the date of communication of this order.
