REFUSAL ORDER

1. Whereas in terms of section 14 (3) (a) of the NCTE Act., 1993, WRC granted recognition to **NAVRACHNA COLLEGE OF EDUCATION, C/O NAVRACHNA EDUCATION SOCIETY, SAMA ROAD, BARODA, GUJARAT** for B.ED course of 1 year duration with an annual intake of 100 students vide order No.WRC/5-6/60/2004/7035-7040 dated. 08.10.2004.

2. And Whereas, the institution applied under section 8 (11) of NCTE Regulations, 2007, for change of premises from **Navrachna College Of Education, C/O Navrachna Education Society, Sama Road, Baroda, Gujarat** to **Navrachna College of Education, Vill- Vasna, Bhilai Road, City- Baroda, Gujarat - 391410** in the office of WRC on 13.06.2011.

3. And Whereas, the application for change of premises was placed in 151st meeting of WRC held on 27th-29th, June, 2011 and the Committee decided that VT be constituted under Clause 8(11) of NCTE Regulations, 2009.

And whereas, the inspection of the institution was conducted on 31.07.2011. The visiting-team report was placed in 154th meeting of WRC and the Committee decided to issue show cause notice under Section 15 (3) (b) of the NCTE Act,1993 on the following points:-

- The application of the college to shift to the Navrachna University as constituent Unit is not permissible as the Navrachna University is currently operating from private leased land, NCTE does not permit the running of any institution from private leased land as per Regulations, 2009.

4. And whereas the applicant institution submitted reply dated 29.11.2011 to WRC, NCTE. The said reply of the institution as well as other documents and material submitted by the institution were placed in 158th meeting of WRC held on 10th-11th January 2012 and the Committee decided that recognition to the said institution be refused for the following reasons:

- The land is on private lease and is not as per NCTE Regulation 2009.

5. Now therefore, Grant for the change of premises from **NAVRACHNA COLLEGE OF EDUCATION, NAVRACHNA EDUCATION SOCIETY, SAMA PO, BARODA-390008, GUJARAT** to **Navrachna College of Education, Vill- Vasna, Bhilai Road, City- Baroda, Gujarat - 391410** for conducting B.Ed. Course is hereby refused.

6. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Ehwani, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
