**WITHDRAWAL ORDER** 922, 923, 924, 925, 926

Whereas, the WRC had granted the recognition to Pt. Madan Mohan Malviya College Of Education, Plot No. - 102, 107/1, 107/2, 108/3, Street-29/89, Bilaspur, Chhattisgarh for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/APP909/154<sup>th</sup>/B.Ed./2011/82044-82050 dt. 29.09.2011.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Pt. Madan Mohan Malviya College Of Education, Run by Rajkoshal Shikshan Samiti, Bilaspur, Chhattisgarh offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 12.01.2015 from the institution, a revised recognition order no. WRC/APP909/2015/142136 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students each) from session 2015-16.

And whereas, the letter no. 2181/Acad./2017 dt. 06.09.2017 received from the Registrar, Bilaspur University, Bilaspur, Chhattisgarh was placed before the WRC in its 281<sup>st</sup> Meeting held on 19<sup>th</sup> - 20<sup>th</sup> September, 2017 and the Committee decided as follows :-

*"The Registrar, Bilaspur University, Bilaspur vide letter dt. 06.09.2017 has brought to the notice of the WRC that following institutions don't have Regular qualified Principal/Staff. The University has temporarily suspended the affiliation of these institutions and requested WRC to take further action in the matter as per NCTE Regulations, 2014.*

**The WRC decided to issue Show Cause Notice to the institutions."**

And whereas, Show Cause Notice u/s 17(1) was issued to the institution on dt. 25.09.2017.

And whereas, the reply dt. 16.10.2017 of institution and a copy of letter no. 2477/Acad./2017 dt. 01.11.2017 from Registrar, Bilaspur University, Bilaspur was placed before the WRC in its 283<sup>rd</sup> Meeting held on November 14<sup>th</sup> - 15<sup>th</sup>, 2017 and the Committee decided as follows :-

*"WRC noted the information received from the University. The University has also informed that the Pt. Madan Mohan Malviya College Of Education, Bilaspur, Chhattisgarh has still not appointed Principals till date.*

**Hence, Recognition of the college is withdrawn from the academic session 2018-2019."**

Now, therefore, the recognition of Pt. Madan Mohan Malviya College Of Education, Plot No. - 102, 107/1, 107/2, 108/3, Street-29/89, Bilaspur, Chhattisgarh for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
