ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

AND WHEREAS, the institution **SUKHWANTI DEVI SHIKSHANA SANSTHANA RUN BY NAVNIDHI SEVA SAMITI, PLOT NO. - 20/9, WARD NO. - 1, VILLAGE + P.O. + TEHSIL - HANUMANA, DIST. - REWA, HANUMANA - 486335, MADHYA PRADESH (WRCAPP211/223)** has by affidavit consented to come under New Regulations and sought for basic unit in **B.ED.** which required additional facilities.

AND WHEREAS, it has been decided to permit the institution to have **one basic unit of 50 student** subject to the institution fulfilling following conditions namely,

- (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii). The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate(LUC) and the Building Plan(BP)in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
- (iii). The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to **SUKHWANTI DEVI SHIKSHANA SANSTHANA RUN BY NAVNIDHI SEVA SAMITI, PLOT NO. - 20/9, WARD NO. - 1, VILLAGE + P.O. + TEHSIL - HANUMANA, DIST. - REWA, HANUMANA - 486335, MADHYA PRADESH** for conducting **B.ED.** programme of 2 (Two) years duration with an annual intake of **50 students (one basic unit)** from the academic session **2015-16** subject to fulfilment of the conditions mentioned herein before 31.10.2015.

Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:

- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

NOTE : WRC in its 226th meeting observed that "LOI dated 03.03.2015 was issued to the institution. In the Letter of Intent, it is clearly mentioned that the applicant should inform whether he wants one or two units of B.Ed. in the light of Appendix-4 of NCTE Regulations, 2014. No response has been received from the institution on this issue. However, the formalities required after issue of LOI have been completed and a duly approved staff profile of 1+15 has been submitted which is needed for two units of B.Ed. It is seen from the documents that the land area is only 2630.8 sq.mts. and the built up area is 1563.33 sq.mts. While this land and built up area was sufficient under the NCTE Regulations, 2009, it is not sufficient under the NCTE Regulations, 2014. In the case of built up area, an applicant has the leeway to increase the built up area as per the new Regulations, 2014 upto 31.10.2015, there is no possibility of the land area be increased."

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
