Withdrawal Order U/S-17 205949

WHEREAS, recognition was granted to the institution, namely, GYANODAY SHIKSHAN SAMITIS, BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTRE, 6, AMBEDKAR MARG, NEEMUCH-458441, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course with an annual intake of 100 students vide order dated 03.11.2003.

2. AND WHEREAS, Shri Dayaram Choudhry filed W.P.No.6094/2014 (PIL) in the Hon'ble High Court at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Duby, wherein the Hon'ble Court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by the NCTE Hqrs.

3. AND WHEREAS, the inspection (U/S-13) was conducted by NCTE Hqrs. on 17.09.2015.

4. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 19-01-2015.

5. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

6. AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255<sup>th</sup> meeting held on 22-24 June, 2016 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

7. AND, WHEREAS, a Show cause notice was issued to the institution on 26.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

8. AND WHEREAS, the reply of show cause notice was submitted by the institution on 13.10.2016.

9. AND WHEREAS, the matter was placed in 310<sup>th</sup> Meeting held on August 19-21, 2019 of WRC and the Committee decided that "...The Show Cause Notice was issued to the institution vide letter dated 26/07/2016 and reply received on 13/10/2016.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake, Building Completion Certificate, and CLU are not submitted in original. Building plan is also not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."
