CONTINUATION ORDER

WHEREAS, recognition was granted to the institution namely, **GYADODAY SHIKSHAN SAMITIS, BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTRE, 6, AMBEDKAR MARG, NEEMUCH-458441 MADHYA PRADESH** under section 14(1) of the NCTE Act, 1993 for conducting B.ED.(CO.ED) course of one year duration with an annual intake of 100 (SEC) (two basic Units of 50 students each) vide order No. WRC/5-6/47/2003/4608 dated 03.11.2003.

AND WHEREAS, the revised recognition order was issued to **GYADODAY SHIKSHAN SAMITIS, BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTRE, 6, AMBEDKAR MARG, NEEMUCH-458441 MADHYA PRADESH** vide order No. WRC/OAPW0565/223072 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution of the condition maintained in revised order"

AND WHEREAS, a Show cause notice was issued to the institution on 26.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

1. Staff Profile for the session 2015-16 duly approved by the affiliating body.
2. Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the matter was placed in 310th Meeting held on 19th -21st August, 2019 and the Committee decided that". The Show Cause Notice was issued to the institution vide letter dated 21/12/2016 and reply received on 31/01/2017.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake, Building Completion Certificate, CLU & building plan are also not submitted in original.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

AND WHEREAS, the Withdrawal order No. WRC/OAPW0565/223072/B.ED/310th/2019/205942 to 205949 was Dated 04.09.2019 issued to the institution.

AND WHEREAS, the matter was placed in 312th Meeting held on January 27th -29th, 2019 and the Committee decided that". The Committee considered the matter keeping in view the order of the Hon'ble Delhi Court in W.P. No. 10424/2019 & CM No. 43025/2019, the Committee decided that the representative of the institution be invited for personal hearing in the next meeting of WRC.

The representative may be requested to come prepared with the following original documents:-

- Staff profile of the institution duly approved by the affiliating body.
- Notarised copy of Change of Land Use, Non-Encumbrance Certificate, Building Plan, Building Completion Certificate and Fixed Deposit Receipts towards Endowment and Reserve Fund."

AND WHEREAS, the matter was placed in 313th Meeting held on February 25th -27th, 2020 and the Committee decided that "As per the decision of WRC in its 312th meeting in compliance of the Court directions, the representatives of the institution appeared before WRC for personal hearing on 25/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents today itself.

AND WHEREAS, the matter was placed in 315th Meeting held on August 10th -11th, and 14th August 2020 and the Committee decided that"

This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 25th February 2020, wherein it was informed that they have submitted the documents to WRC Office.

The WRC noted that the examined the documents submitted by the institution and observed the following deficiencies: -

- **The faculty at Sr. No. 10 and 17 of the staff list are not qualified as per NCTE Regulations 2014, as amended vide notification dated 09.06.2017.**

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act.

AND WHEREAS, Accordingly, a Show Cause notice was issued on 27.08.2020 the institution has submitted reply received on 23.09.2020

AND WHEREAS, the Matter was considered by WRC in its 336th Meeting held on 24th -25th March 2021 and WRC decided (Ref: Sl. No. 22, Page No. 17-18 of 336th WRC Minutes) as under:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTRE, 6 AMBEDKAR MARG, NEEMUCH 458441, MADHYA PRADESH for B.Ed programme for 2 basic units of 50 students in each unit:-**

NOW THEREFORE, the recognition of **GYADODAY SHIKSHAN SAMITIS, BALKAVI BAIRAGI TEACHER EDUCATION RESEARCH CENTRE, 6, AMBEDKAR MARG, NEEMUCH-458441 MADHYA PRADESH** for conducting B.Ed. (CO.ED) course with an with an annual intake of 100 (SEC) (two basic Units of 50 students each) is permitted to continue Recognition order from the withdrawal Order WRC/OAPW0565/223072/B.ED/310th/2019/205942 to 205949 Dated 04.09.2019 with an annual intake of 100 students (two basic units).
