WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to M S EDUCATION INSTITUTE SAMITI, PLOT NO.1839, STREET NO.75, VILLAGE-GATHEORA, BAJARANG NAGAR, P.O./TEHSIL/CITY/ DISTRICT-CHHATARPUR, PIN CODE- 471001, MADHYA PRADESH for D.El.Ed. course vide order dated 01.08.2012 for an annual intake of 50 students.

AND WHEREAS, the institution applied under clause 8(9) of NCTE Regulations 2014, for change of premises of D.El.Ed course from M S EDUCATION INSTITUTE SAMITI, PLOT NO.1839, STREET NO.75, VILLAGE-GATHEORA, BAJARANG NAGAR, P.O./TEHSIL/CITY/ DISTRICT-CHHATARPUR, PIN CODE- 471001, MADHYA PRADESH to **M.S. EDUCATION INSTITUTE SAMITI, PLOT NO. 869, 870, 871, VILLAGE - GATHEORA, PANNA ROAD, CHHATARPUR, MADHYA PRADESH.**

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on 03.02.2017.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its 278th Meeting held on July 25-26, 2017. The Committee decided that "...This is a case of shifting. VT visited the institution on dt.03.02.2017.The CD was seen and the VTR was perused. The CD shows a building with adequate instructional and infrastructural facilities. VT has recommended the case. **Hence, Shifting is permitted.**"
