WHEREAS, recognition was granted to the institution, namely, S.S.N.M.I.M.T. COLLEGE, JHIRNA ROAD, NARSINGHPUR 487001 MADHYA PRADESH vide order No. WRC/5-32/F.O/2006/9797-9856 dated 28.10.2006 for B.ED. (CO-ED) Course with an annual intake of 100 students.

AND WHEREAS, Shri Dayaram Choudhry filed W.P. No.6094/2014. (PIL) in the Hon'ble High Court at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Dubey, wherein the Hon'ble court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by the NCTE Hqrs.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 15.09.2015.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 26.03.2015.

AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 28.05.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 12.02.2016. and the reply of Deficiency Letter was received in WRC on 08.03.2016 & 18.08.2016 and forwarded to NCTE Hqrs.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 11.07.2016.

AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... issue Show Cause Notices to the institution of the condition maintained in revised order."

AND, WHEREAS, the Show Cause Notice was issued to the institution on 26.05.2017 and the reply of Show Cause Notice was received on 16.06.2017.

AND WHEREAS, the matter was placed in 280<sup>th</sup> Meeting held on August 31<sup>st</sup>- September 01<sup>st</sup>, 2017 of WRC and the Committee decided that "... Deficiency letter was issued to the institution on 12.02.2016. The institute replied on 08.03.2016 & 18.08.2016. However, it needs to submit the staff profile on the NCTE proforma duly signed by the Registrar. The institute should also submit proof regarding payment of CPF/EPF and bank statement regarding the salary of staff.

**Show Cause Notice be issued on the above grounds. Reply should be received within 1 month."**

AND, WHEREAS, the Show Cause Notice was issued to the institution on 06.09.2017 and the reply of Show Cause Notice was not received.


AND WHEREAS, the matter was placed in 287<sup>th</sup> Meeting held on January 30-31, 2018 of WRC and the Committee decided that "... Show Cause Notice was issued to the institution on 06.09.2017. Till date no reply has been received.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs if any, be returned"

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
