### RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, S.S.N.M.I.M.T. COLLEGE, JHIRNA ROAD, NARSINGHPUR - 487001, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED).course vide order dated 28.10.2006 for an annual intake of 100 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 24.03.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 28.05.2015.

AND, WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 26.05.2017 and reply of compliance received on 16.06.2017.

AND WHEREAS, the matter was placed in 280<sup>th</sup> Meeting held on August 31 - September 01, 2017 of WRC and the Committee decided that "...Deficiency letter was issued to the institution on 12.02.2016. The institute replied on 08.03.2016 & 18.08.2016. However, it needs to submit the staff profile on the NCTE proforma duly signed by the Registrar. The institute should also submit proof regarding payment of CPF/EPF and bank statement regarding the salary of staff. Show Cause Notice be issued on the above grounds. Reply should be received within 1 month."

AND WHEREAS, the Show Cause Notice was issued on 06.09.2017 and the reply of show cause notice was not submitted by the institution.

AND WHEREAS, the matter was placed in 287<sup>th</sup> Meeting held on January 30-31, 2018 of WRC and the Committee decided that "...Show Cause Notice was issued to the institution on 06.09.2017. Till date no reply has been received.

**Hence, Recognition is withdrawn from the academic session 2018-2019."**

AND WHEREAS, the Withdrawal Order issued on 02.02.2018. The institution filed a appeal to the appellate authority Hqrs. no. APPL12227 dated 26.02.2018. Regulatory file sent to Hqrs.

AND WHEREAS, the appeal order dated 12.07.2018, Committee concluded that case deserves to be remanded back to W.R.C. for considering the reply to S.C.N. said to have been sent by the appellant. Appellant is required to send to W.R.C. a copy of its earlier reply to S.C.N. within 15 days of the issue of appeal order.

The council hereby remands back the case of S.S.N.M.I.M.T. College, Narsinghpur, Kandeli, Narsinghpur, Madhya Pradesh to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 295<sup>th</sup> Meeting held on July 30 - 31, 2018 of WRC and the Committee decided that "...This is a case of appeal. The Appellate Authority vide order dated 12.07.2018 has remanded the case to WRC for further processing the application




