WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, ANJUMAN COLLEGE OF EDUCATION, KHASRA/PLOT NO.269/70, STREET NUMBER/VILLAGE - CHAROKHRA, POST OFFICE - BHAGUAPURA, TEHSIL /TALUKA - SEONDHA, TOWN/CITY/DISTRICT - DATIA, PIN CODE - 475673, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting D.El.Ed. course with an annual intake of 100 students vide order dated 17.06.2016.

AND WHEREAS, Letter issued to the NATIONAL COMMISSION FOR MINORITY EDUCATIONAL INSTITUTIONS, NEW DELHI for validation of minority certificate on 16.07.2016 & 30.01.2018.

AND WHEREAS, reply received from the National Commission for Minority Education was placed in 290th WRC meeting held on March 21-23, 2018 and the Committee observed that "...Recognition was granted for one unit of D.El.Ed. course vide order dated 17.06.2016 on the basis of the minority certificate. Subsequently, the minority certificate was sent to the National Commission for minority Educational institutions, New Delhi and the Commission vide letter dated 07.03.2018 has informed that the Commission has not issued Minority Certificate to the institution. Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month." Accordingly, Show Cause Notice issued on 26.03.2018.

AND WHEREAS, reply not received from the institution. The matter was placed in 293rd WRC meeting held on June 12-14, 2018 and the Committee observed that "...The Minority Certificate produced by the institution was sent to the National Commission for Minority Educational institutions, New Delhi for validation. The Commission vide letter dated 07.03.2018 has informed that it had not issued the Minority Certificate to the institution under case No. 1276 of 2016. Show Cause Notice was issued to the institution on 26.03.2018 and reply has not been received so far. Hence, Recognition is withdrawn from the session 2018-19. FDRs, if any, be returned."

NOW THEREFORE, the recognition granted to ANJUMAN COLLEGE OF EDUCATION, KHASRA/PLOT NO.269/70, STREET NUMBER/VILLAGE - CHAROKHRA, POST OFFICE - BHAGUAPURA, TEHSIL /TALUKA - SEONDHA, TOWN/CITY/DISTRICT - DATIA, PIN CODE - 475673, MADHYA PRADESH for conducting D.El.Ed. course vide order dated 17.06.2016 is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the next academic session 2018-2019.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 13 of the NCTE Act, 1993 within 60 days of the issue of this order.
