WHEREAS, recognition was granted to the institution namely ANJUMAN COLLEGE OF EDUCATION, RUN BY ANJUMAN TARRKKI ALAPSHANKYAK SHIKSHA PRASAR SAMITI, PLOT/ KHASRA NO.269/70, VILLAGE/STREET NUMBER- CHAROKHARA, POST OFFICE - BHAGUAPURA, TEHSIL/TALUKA - SEONDHA, TOWN/CITY/DISTRICT- DATIA-475673, MADHYA PRADESH vide Order No. WRC/NCTE/APP3287/254th/D.El.Ed./{M.P}/2016/169253-169260 dated 17.06.2016 for D.El.Ed. course of Two (2) years duration with an annual intake of 100 students (Two basic units of 50 each).

AND WHEREAS, letter issued to the NATIONAL COMMISSION FOR MINORITY EDUCATIONAL INSTITUTIONS, NEW DELHI for validation of minority certificate on 16.07.2016 & 30.01.2018.

AND WHEREAS, reply received from the National Commission for Minority Education was placed in 290th WRC meeting held on March 21-23, 2018 and the committee observed that "...Recognition was granted for one unit of D.El.Ed. course vide order dated 17.06.2016 on the basis of the minority certificate. Subsequently, the minority certificate was sent to the National Commission for minority Educational institutions, New Delhi and the Commission vide letter dated 07.03.2018 has informed that the Commission has not issued Minority Certificate to the institution. Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month." Accordingly, Show Cause Notice was issued on 26.03.2018.

AND WHEREAS, reply not received from the institution. The matter was placed in 293rd WRC meeting held on June 12-14, 2018 and the Committee observed that "...The Minority Certificate produced by the institution was sent to the National Commission for Minority Educational institutions, New Delhi for validation. The Commission vide letter dated 07.03.2018 has informed that it had not issued the Minority Certificate to the institution under case No. 1276 of 2016. Show Cause Notice was issued to the institution on 26.03.2018 and reply has not been received so far. Hence, Recognition is withdrawn from the session 2018-19. FDRs, if any, be returned." Accordingly, Withdrawal order was issued to the institution on 18.06.2018.

AND WHEREAS, the institution has filed an appeal to NCTE, Hqrs. on 05.09.2018. The Appellate Authority vide its appeal order dated 31.12.2018 remanded back the case to the WRC, NCTE, for necessary action and reply received on 26.03.2018 & 10.01.2019 in response to Appellate Authority.

AND WHEREAS, the institution has filed W.P. 7365/2019 in the High Court of Delhi, Bench at New Delhi passed an order dt. 10.07.2019.

AND WHEREAS, the matter was placed in 309th WRC meeting held on July 23-26, 2019 and the Committee observed that "The committee considered case in the light of the order dated 10/07/2019 passed by the Hon'ble High Court of Delhi in W.P. No. 7365/2019 and appeal order dated 31/12/2018. The institution needs to submit certified copy of minority certificate issued by the competent authority within 30 days to process the case further." Accordingly, Compliance letter issued to the institution on 08.08.2019.

AND WHEREAS, reply received from the NATIONAL COMMISSION FOR MINORITY EDUCATIONAL INSTITUTIONS on 23.09.2020.

AND WHEREAS, the matter was placed in 332nd WRC meeting held on March 01-02, 2020 and the Committee observed that "The original file of the Institution along-with other related documents

were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

1. The institution has submitted certified copy of minority certificate issued by the competent authority, which were considered by the Committee and found fit the case for continuing recognition to D.El.Ed. programme within intake of 100 students (Two units) to the institution.

In view of above, the Committee decided as under:

Recognition granted to the institution be continued for D.El.Ed course for Two units of 50 students each."
