WITHDRAWAL ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, ANJUMAN TARRAKKI ALAPSHANKYAK SHIKSHA PRASAR SAMITI, PLOT NO- 143, VILLAGE+ STREET- VINAY NAGAR, SECTOR-3, POST OFFICE- VINAY NAGAR, TEHSIL- GWALIOR, CITY- GWALIOR, DISTRICT: GWALIOR- 474012, MADHYA PRADESH had submitted the online application on 30-06-2015 to the Western Regional Committee of the NCTE for grant of recognition to ANJUMAN COLLEGE OF EDUCATION, PLOT NO- 69/MIN 2, 70/MIN 2, STREET- CHAROKHIRA, VILLAGE- CHAROKHIRA, POST OFFICE- BHAGUAPURA, TEHSIL- SEONDHA, CITY- DATIA, DISTRICT: DATIA- 475673, MADHYA PRADESH for starting the B.ED. Course.

AND WHEREAS, Department of Higher Education, M.P., Bhopal vide letter dated 09.10.2015 has given the recommendation.

AND WHEREAS, the WRC in its 241st meeting held on February 04-06, 2016 it was decide as under:-

"The WRC decided that the WRO should process these, constitute VTs where all documents are in order and issue Show Cause Notice to the rest. Action taken should be reported in the next meeting of the WRC."

Hence, in view of the above, Show Cause Notice is issued on the following points:-

1. Society Registration Certificate submitted but Bye-Laws not submitted.
2. Total Land area not mentioned in the affidavit.
3. Photocopy of Building Plan submitted but Blue Print/notarized copy not submitted.
4. Notarized copy of Building Completion Certificate not submitted.
5. Notarized copy of Change of Land Use Certificate not submitted.
6. Notarized copy of Non-Encumbrance Certificate not submitted.
7. FDRs not submitted, as per NCTE norms.
8. Serial No.5 not filled in the Affidavit.
9. In Online Application Form & as per office record, institution has not applied for /nor conducting any other Teacher Education Course. Hence, institution is not fulfilling Clause 2(b) of NCTE Regulations, 2014.
10. As per Online Application Form institution is Minority but as per record, no documentary proof of institution being Minority & Institution has applied for Minority Certificate.

AND WHEREAS, the Show Cause Notice was issued to the institution on 10.02.2016 and the reply was received on 09.03.2016.

AND WHEREAS, the reply was placed before the WRC in its 247th WRC Meeting held on April 04-06, 2016 and the Committee observed that "...The institution has applied for the B.Ed. course (APP3293) and for the D.El.Ed. course (APP3287). This is a Minority institution.

Show Cause Notice was issued to the institution on 09/02/2016 on the grounds that the Originally certified copy of the land documents is not submitted, as also notarized copies of CLU, Building Plan, Building Completion Certificate, and Non-Encumbrance Certificate. NOC from the affiliating body is not submitted as also notarized copy of the Minority Certificate. It has also been pointed out that Survey/khasra number differs in application, land documents, and Building Plan.

The institution vide its reply dt. has submitted notarized copies of CLU, building plan, Building Completion Certificate, Non-Encumbrance Certificate and Minority Certificate. It has also submitted the originally certified copy of land documents.

Hence, VT be constituted."

AND WHEREAS, the inspection letter issued to the institution on 09.04.2016 and the inspection conducted of the institution on 14.04.2016.

AND WHEREAS, the VT was placed before the WRC in its 249th Meeting held on April 21-23, 2016 and the Committee observed that "...The VT visited the institution on 14/04/2016. The VT report was perused and the CD viewed. The CD shows a good building with adequate infrastructural and instructional facilities. The VT has recommended the case.

Hence, LOI be issued.

The Applicant be informed that the case will be considered for the session 2016-2017, only if the formalities necessary after issue of LOI are completed well before 2nd May, 2016."

AND WHEREAS, the Letter of Intent under Clause 7(13) of the NCTE Regulations, 2014 was issued on 26.04.2016 and the reply received on 29.04.2016.

AND WHEREAS, the reply was placed before the WRC in its 254th Meeting held on June 7-9, 2016 and the Committee observed that "...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal and 7 faculty members, who are qualified and approved by the affiliating body.

Hence, Recognition is granted for one unit of 50 students for the B.Ed. course from the academic session 2017-2018."

AND WHEREAS, Recognition Order was issued to the institution on 20.06.2016.

AND WHEREAS, letter was sent to the Registrar, Jiwaji University, Gwalior on 16.07.2016 regarding verification of NOC & Staff Profile but replies not received.

AND WHEREAS, letter was sent to the SDO, Sewdha, Datia, M.P. on 16.07.2016 regarding verification of the CLU and the reply not received.

AND WHEREAS, letter was sent to the Chairman, National Commission for Minority Educational Institutions, New Delhi on 16.07.2016 regarding verification of Minority Certificate but reply not received to till date.

AND WHEREAS, in 281st Meeting of WRC held on September 19th -20th, 2017 and the committee has decided that: "Initiation of the process of de-recognition of institutions for non compliance of filing the Mandatory Affidavit - reg.

In order to systematise the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017.

NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard to the address as well as duplication of entries for placing the list to WRC for initiating the process of de-recognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the HQrs. as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be de-recognized. The reply should be sent on or before 23rd October 2017 after which further necessary action will be taken as per the Regulations."

AND WHEREAS, the Show Cause Notice (MAS) was issued to the institution on 23.09.2017 and the reply was not received to till date.

AND WHEREAS, Reminder letter-I was sent to the SDO, Sewdha, Datia, M.P. on 30.01.2018 regarding verification of the CLU and the reply not received to till date.

AND WHEREAS, Reminder letter-I was sent to the Chairman, National Commission for Minority Educational Institutions, New Delhi on 30.01.2018 regarding verification of Minority Certificate and the reply received on 13.03.2018.

AND WHEREAS, the matter was placed before the WRC in its 290th WRC Meeting held on March 21-23, 2018 and the Committee observed that "...Recognition was granted for one unit of B.Ed. course vide order dated 20.06.2016 on the basis of the minority certificate. Subsequently, the minority certificate was sent to the National Commission for minority Educational institutions, New Delhi and the Commission vide letter dated 07.03.2018 has informed that the Commission has not issued Minority Certificate to the institution.

Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month."

AND WHEREAS, the Show Cause Notice was issued to the institution on 27.03.2018 and the reply was not received to till date.

AND WHEREAS, the reply was placed before the WRC in its 293rd WRC Meeting held on June 12-14, 2018 and the Committee observed that "...The case file was seen. The Minority Certificate produced by the institution was sent to the National Commission for Minority Educational institutions, New Delhi for validation. The Commission vide letter dated 07.03.2018 has informed that it had not issued the Minority Certificate to the institution under case No. 1276 of 2016. Show Cause Notice was issued to the institution on 26.03.2018 and reply has not been received so far.

Hence, Recognition is withdrawn from the session 2018-19.
FDRs, if any, be returned."

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing of appeal may be seen on NCTE website.
