WHEREAS, WRC, NCTE had granted recognition/permission to SHIVAM SHIKSHA MAHAVIDHYALAY RUN BY SHRI SHRI 108 BABA BALAKDAS SHIKSHA PRASAR AVAM ANUSUCHIT JATI KALYAN SAMITI, PLOT NO. - 349, 353, 356 MIN 8, VILLAGE + P.O. + TEHSIL - PORSIA, DISTRICT - MORENA, - 476115, MADHYA PRADESH vide order dated 05.02.2014 to start the B.ED. (CO-ED) course with an annual intake of 100 students.

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015. The institution submitted affidavit vide letter dated 12.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (50 students each) to the institution on 19.05.2015.

AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... issue Show Cause Notices to the institution of the condition maintained in revised order."

AND, WHEREAS, a Show cause notice was issued to institution on 28.02.2017 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure.

AND WHEREAS, a letter was submitted by the institution on 14.03.2017 with a request of resolution passed by society for closure of one unit of B.Ed. course from the academic session 2017-18.

AND WHEREAS, the matter was placed in 259<sup>th</sup> Meeting of WRC held on September 21-23, 2016 and the Committee decided that "... Institutions which have requested for reducing intake may be permitted."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)


