**Withdrawal Order U/S-17**

WHEREAS, recognition was granted to the institution, namely, SHRI VARDHMAAN SHIKSHA MAHAVIDYALAYA, TILAK COLLEGE ROAD, KATNI 483501 MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 16.03.2008 with an intake of 100 students.

2. AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

3. AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 25.03.2015.

4. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 05-02-2015.

5. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

6. AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to Issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

7. AND WHEREAS, a Show cause notice was issued to the institution on 30.11.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Original Staff Profile (1-Principal+15-Faculties) for the session 2015-16 duly approved by the affiliating body,
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate in Prescribed format.

8. AND WHEREAS, the reply of Show Cause Notice was received on 20.01.2017 by the institution & the matter was placed in 310<sup>th</sup> Meeting of WRC held on August 19<sup>th</sup> - 21<sup>st</sup>, 2019 and the Committee decided that "... The Show Cause Notice was issued to the institution vide letter dated 30/11/2016 and reply received on 20/01/2017.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake is not submitted in original. CLU & FDRs of 12 lakhs are also not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
