RESTORATION ORDER

209680

WHEREAS, recognition was granted to the Institution, namely, **SHRI VARDHMAAN SHIKSHA MAHAVIDYALAYA, TILAK COLLEGE ROAD, KATNI- 483501, MADHYA PRADESH** under section 14(3)(a) of NCTE Act, 1993 for conducting **B.ED.(CO.ED)** course for 100 students vide order No. WRC/5-6/APW05743/223619/M.P./2008/30721 dated 16.03.2008.

2. AND WHEREAS, the revised recognition order was issued to **SHRI VARDHMAAN SHIKSHA MAHAVIDYALAYA, TILAK COLLEGE ROAD, KATNI- 483501, MADHYA PRADESH** vide order no. WRC/A APW05743/223619/2015/144170-198 dt. 31.05.2015 for **B.ED.** Programme of two years duration with an annual intake of 50 students (One unit) from the academic session 2015-16 with certain conditions.

3. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

4. AND WHEREAS, a Show Cause Notice was issued to the institution on 30.11.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

5. AND WHEREAS, the reply of Show Cause Notice was submitted by the institution on 20.01.2017 by the institution

6. AND WHEREAS, the matter was placed in 310th Meeting of WRC held on August 19th -21st, 2019 and the committee decided that "The Show Cause Notice was issued to the institution vide letter dated 30/11/2016 and reply received on 20/01/2017."

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake is not submitted in original. CLU & FDRs of 12 lakhs are also not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

7. AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

8. AND WHEREAS, the institution has filed an appeal NCTE, Hqrs. on 14.11.2019. The Appellate Authority vide its order dated 13.12.2019 remanded back the case to the WRC, NCTE, for necessary action. Accordingly, institution has submitted documents in WRO on 26.12.2019 received.

9. AND WHEREAS, the matter was placed in 313th Meeting of WRC held on June 25th to 27th February 2020 and the Committee decided that: "The Committee considered the matter keeping in view the

directions of the Appellate Authority order dated 05.10.2019 and decided that Show Cause Notice u/s 17 of the NCTE Act be issued on the institution on following grounds:-

(i) The BCC is not in the name of the institution.

In view of the above, a Show Cause Notice be issued u/s 17 of the NCTE Act to the institution to reply within 30 days."

10. AND WHEREAS, the Show Cause Notice was issued to the institution on 16.03.2020.

11. AND WHEREAS, the reply of Show Cause Notice was submitted by the institution vide letter dt.16.03.2020 WRO received in 16.03.2020

12. AND WHEREAS, the matter was placed in 315th Meeting of WRC held on August 10th-11th and 14th 2020 and the Committee decided that:- *This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing. The show cause notice was issued to the institution for submission of compliance on 16th March 2020. The institution submitted the reply vide dated 16th March 2020.*

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for B.Ed course with an annual intake of 100 students (Two Units) be restored.

13 AND WHEREAS, the matter was placed in 316th Meeting of WRC held on August 27th to 28th August and 04th September 2020 and the Committee decided that:- *This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.*

The show cause notice was issued to the institution for submission of compliance on 16th March 2020. The institution submitted the reply vide dated 16th March 2020.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for B.Ed course with an annual intake of 100 students (Two Units) be restored from the date of issue of order.

13 NOW THEREFORE, the recognition of, **SHRI VARDHMAAN SHIKSHA MAHAVIDYALAYA, TILAK COLLEGE ROAD, KATNI- 483501, MADHYA PRADESH** restored for conducting B.Ed. course with an annual intake of 100 students (Two unit) from the date of issue of order.
