ORDER

WHEREAS, in terms of Section 14(3)(a) of NCTE Act, 1993, recognition was granted to the institution namely, "Yash Shikshan Sansthan and Gramin Vikas Samiti 40, Shikshak Colony Choupati, Badnawar, Dhar-454660, Madhya Pradesh for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2005-2006 vide Order No. WRC/5-6/APW01771/223322/75/2007/C-15218 dated 04.05.2007.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014 the institution had consented to come under new Regulation by affidavit, and the Revised Recognition Order (RPRO) was issued to the institution vide Order No. WRC/APW01771/223322/2015/142813-69 dated 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units of 50 students each) students from the academic session 2015-2016 for compliance of certain.

3. AND WHEREAS, the institution has submitted request letter dated 09.09.2025 & 06.01.2026 regarding change the name of institution from Yash Shikshan Sansthan and Gramin Vikas Smiti to Yash College of Education.

4. AND WHEREAS, the institution filed a Writ Petition in the Hon'ble High Court of Delhi at New Delhi, and the Hon'ble High Court of Delhi in W.P. No. 1395/2026 vide Order dated 03.02.2026.

5. AND WHEREAS, the matter was considered in its 451<sup>st</sup> (P-II) meeting held on 25<sup>th</sup> February 2026 Committee decided to issue letter. Accordingly, as per the decision of WRC letter was issued to the institution on 25.03.2026. the institution has submitted reply vide letter dated 01.04.2026 received on 09.04.2026 and the affiliating university has submitted reply received on 08.04.2026.

6. AND WHEREAS, the matter was consider WRC in its 457<sup>th</sup> (Part-1-A) meeting held on 20<sup>th</sup> to 22<sup>nd</sup> April, 2026, the Committee decided as under:-

*"On careful perusal of the original file of the institution and other related documents, and having considered the same in terms of the NCTE Act, 1993, Rules and Regulations issued by NCTE from time to time, the directions of the Hon'ble Court, and the documents submitted by the institution pursuant to the communications issued by the WRC office in accordance with the minutes of the 451st Meeting (Part-II), the Committee observed as under:*

*The institution filed a Writ Petition in the Hon'ble High Court of Delhi at New Delhi, and the Hon'ble High Court of Delhi in W.P. No. 1395/2026 vide Order dated 03.02.2026 has passed the following decision: -*

*"1. This is a writ petition filed under Article 226 of the Constitution of India seeking the following prayers:*

- *Direct the Respondent to decide the Representations made by the Petitioner Society to incorporate the name of its Yash College of Education, in the formal recognition orders issued to it, by the Respondent No.2 itself; which otherwise, were required to be issued in the name of "Yash College of Education" only, in place of the name of the Petitioner Society herein; and/or..."*
- *It is the case of the petitioner that the petitioner society seeks decision on its representation regarding the correction in the name of the college, which is being maintained by the petitioner society.*
- *Ms. Malhotra, learned counsel for the respondents, states that the respondents have recognized the name as given by the petitioner and there is no mistake/error on part of the respondents.*
- *However, dehors the same, she states that the representation of the petitioner will be decided appropriately and expeditiously.*
- *Taking her statement on record and binding the respondents to the said statement, the petition is disposed of in the aforesaid terms.*
- *In case the petitioner is aggrieved, the petitioner shall be at liberty to take appropriate actions in accordance with law."*

*The Committee, upon consideration of the above facts, noted that the institution had submitted the requisite documents in support of its request for change of name vide letters dated 09.09.2025 and 06.01.2026, seeking change of the name from "Yash Shikshan Sansthan and Gramin Vikas Smiti" to "Yash College of Education" in the recognition order(s) issued by NCTE. The Committee decided to allow the request for change of name from "Yash Shikshan Sansthan and Gramin Vikas Smiti" to "Yash College of Education" for offering B.Ed. course."*

**NOW THEREFORE**, as per the decision of WRC the name of the Institution is changed from "Yash Shikshan Sansthan and Gramin Vikas Smiti" to "Yash College of Education" for offering B.Ed. course".
