RESTORATION ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to MAHARISHI VEDVYAS MAHAVIDYALAYA, RUN BY - DHARAM SHIKSHA SAMITI, JUNGIPUR, DISTRICT.- GWALIOR, MADHYA PRADESH vide order dated 25.08.2008 to start the B.ED. course with an annual intake of 100 students.

2. AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015. The institution submitted affidavit vide letter dated 16.01.2015.

3. AND WHEREAS, Revised Recognition order was issued for two basic units (50 students each) to the institution on 31.05.2015.

4. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, the Compliance Show Cause Notice was issued to the institution on 23.05.2017 and the reply of Show Cause Notice was received on 27.06.2017.

6. AND WHEREAS, the matter was placed in 285th Meeting of WRC held on December 19th-21st, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 23.05.2016, the institution has not submitted approved staff profile.

Building Completion Certificate not submitted. FDRs of Rs.12.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn. FDRs if any, be returned."

7. AND WHEREAS, Withdrawal order was issued to the institution by the WRC on 08.01.2018.

8. AND WHEREAS, an appeal no. APPL12294 was filed by the institution u/s-18 of the NCTE Act, 1993 Appeal dated on 12.03.2018.

9. AND WHEREAS, the appeal order dated 12-09-2018, after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the WRC for revisiting the matter, after the appelland institution submits required documents and taking further action expeditiously.

NOW THEREFORE, the Council hereby remands back the case of Maharshi Vedvyas Mahavidyalaya, Jangipur, Pichhor, Dabra, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

10. AND WHEREAS, the matter was placed in 299th Meeting held on October 30th - 31st November 01st 2018 of WRC and the Committee decided that "...This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC with the specific direction to the Appellant to submit complete list alongwith all supporting documents submitted by them in appeal to the Regional Committee within 15 days of the issue of appeal order.

The Committee observed that:-

(i) The appellant institution has not submitted the required documents within the stipulated time ordered by the Appellate Authority.

(ii) FDR for Rs.12.00 lakhs in original as required under clause 10(1) of NCTE Regulations, 2014 not submitted.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993.

11. AND WHEREAS, the Show Cause Notice was issued to the institution on 16.11.2018 and the reply of Show Cause Notice was received on 07.12.2018.

12. AND WHEREAS, the matter was placed in 300th Meeting held on December 17th-18th 2018 of WRC and the Committee decided that "... Show Cause Notice was issued to the institution on 16.11.2018 for submission of staff profile, Building Completion Certificate and FDRs.

The institution vide letter dated 19.11.2018 submitted:-

- (a) Staff list of seven faculty members;
- (b) Photocopy of Building Completion Certificate; and
- (c) FDRs for Rs.12.00 lakhs.

Institution has submitted a list of one Principal and nine faculty members, who are qualified and approved. The Building Completion Certificate and FDRs have also been submitted.

Hence, Recognition is restored."

13. NOW THEREFORE, the recognition of MAHARISHI VEDVYAS MAHAVIDYALAYA, RUN BY - DHARAM SHIKSHA SAMITI, JUNGIPUR, DISTRICT.- GWALIOR, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is hereby restored.
