WHEREAS, recognition was granted to the institution, namely, SRI SATYA SAI COLLEGE FOR WOMEN, H.E. HOSPITAL, HABIBGANJ, BHOPAL-462021, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course (100 Intake) vide order dated 22.04.1999.

2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 13-01-2015.

3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, a Show cause notice was issued to the institution on 21.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 12.08.2016.

7. AND WHEREAS, the matter was placed in 284th Meeting of WRC held on November 28th-29th, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 21.07.2016, the institution has submitted a list of 1+9 faculty members, which is not approved by the Registrar. The staff profile as per Appendix-IV of NCTE Regulations, 2014, approved by the affiliating body should be submitted in original.

It has not submitted the Building Completion Certificate countersigned by the Govt. Engineer.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

8. AND WHEREAS, the reply of clarification letter was issued to the institution and reply was submitted by the institution on 21.12.2017.

9. AND WHEREAS, the matter was placed in 301st Meeting of WRC held on January 17th-18th, 2019 and the Committee decided that "...

11. AND WHEREAS, the matter was placed in 310th Meeting of WRC held on August 19th-21st, 2019 and the Committee decided that "...The Show Cause Notice was issued to the institution vide letter dated 21/12/2016 and reply received on 14/02/2017.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake CLU, Building Completion Certificate, Building Plan & NEC are also not submitted in original.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

12. AND, WHEREAS, the withdrawal order was issued to the institution on 04.09.2019.

13. AND, WHEREAS, the institution filed an Appeal to the Council On 04.09.2019 and the Council vide its order dated 06.11.2019 the Council hereby remanded back the case to the WRC, NCTE for necessary action and accordingly the institute submitted related documents in WRO vide letter dated 19.11.2019.

14. AND WHEREAS, the matter was placed in 313th Meeting held on February 25th-27th, 2020 of WRC and the Committee decided that **"...The Committee considered the matter keeping in view the order of the Appellate Authority dated 06.11.2019 and decided that the recognition of the institution be restored with the existing annual intake of two units (100 students)."**

15. NOW THEREFORE, the recognition of, **SRI SATYA SAI COLLEGE FOR WOMEN, H.E. HOSPITAL, HABIBGANJ, BHOPAL-462021, MADHYA PRADESH** is restored for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each).
