Recognition Order

WHEREAS in terms of Section 14(3) (a) of the NCTE Act, 1993, recognition was granted to RAJEEV GANDHI COLLEGE OF EDUCATION, SANCHI ROAD, RAISEN, Madhya Pradesh (Code No.- APW01738/223310) for conducting B.ED. course for the academic session 2005-2006 with an annual intake of 100 students vide order No. WRC/2-32/223310/76/2005/6202 dated 9.08.2005.

2. AND WHEREAS in its 121st meeting held on July ,8-9 ,2009 the Western Regional Committee after considering the report of the visiting team as well as other relevant material furnished by the applicant institution decided to refuse the recognition on the said institution for B.ED course under section 17 (1) of NCTE Act, 1993 and accordingly the Refusal order No.NCTE/WRC/MP/APW01738/223310/121/2009/59398 dated 19.08.2009 was issued to the institution.

3 AND WHEREAS the correspondent, RAJEEV GANDHI COLLEGE OF EDUCATION, SANCHI ROAD, RAISEN, Madhya Pradesh has preferred an appeal to NCTE New Delhi under section 18 of the NCTE Act, 1993 against the said refusal order dated 19.08.2009.

4. AND WHEREAS Council passed an order No F.No.89-1212/2009-Appeal/A-10937 dated 22.02.2010 in the appeal filed by the institution and set aside the order of WRC 19.08.2009 with direction to WRC to restore the recognition of the institution immediately.



NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, and as per the NCTE, New Delhi Order No. F.No.89-1212/2009-Appeal/A-10937 dated 22.02.2010 the Western Regional Committee hereby restore recognition granted to RAJEEV GANDHI COLLEGE OF EDUCATION, SANCHI ROAD, RAISEN, Madhya Pradesh grant recognition vide order No. WRC/2-32/223310/76/2005 dated 9.08.2005 for conducting B.ED course for 1 year duration with for basic unit of an annual intake of 100 seats under clause 7 (11) of NCTE (Recognition Norms & Procedure) Regulation 2009.
