ORDER 485

WHEREAS, WRC, NCTE had granted recognition/permission to KAMAKHYA SHIKSHA B.ED. COLLEGE RUN BY SHRI KAMAL SHIKSHA EVAM BAL KALAYAN SAMITI, PLOT.NO.-3173/1/kha, DATIA ROAD, VILLAGE + P.O. - MAU, TEHSIL - GOHAD, DIST. - BHIND, - 477222, MADHYA PRADESH vide order dated 05.02.2014 to start the B.ED. (CO-ED) course with an annual intake of 100 students.

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015. The institution submitted affidavit vide letter dated 05.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 13.05.2015.


AND WHEREAS, a letter was submitted by the institution on 22.09.2015 with a request of resolution passed by society for closure of one unit of B.Ed. course from the academic session 2017-18.

AND WHEREAS, the matter was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that "... Institutions which have requested for reducing intake may be permitted."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)
