Order

Whereas, recognition was granted to **Shri Jhulelal Science College, BGS College, Taraganj, Gol Pahadia Road, Near Samadia Colony, Lashkar, Gwalior-474001, M.P.** under Section 14 (3) (a) of the NCTE Act, 1993 for conducting B.ED. Course vide order No. **WRC/5-6/49(SCM)/2003/525-31 dated 11.02.2004.**

And, whereas, the recognition of B.Ed. course to the institution was refused by WRC in its 115th meeting vide order No. WRC/MP/APW00104/223121/115/2009/53656-53661 dated 11.04.2009.

And, whereas, the institution filed W.P. No. 152/ 11 in the Hon'ble High Court of M.P. Bench at Gwalior. The Hon'ble High Court passed an order dated 10.03.2011 that "The respondents are directed to include name of the petitioner institution for admission of students to B.Ed. course for the academic session 2010-2011. However this order is subject to order passed by the WRC on remand. Looking to the facts of the case, there shall be no order as to costs".

And, whereas, the original file of the institution, Court order and other relevant documents were placed before WRC in its 149th meeting held on 4th to 6th May, 2011 and the Committee decided that the name of the institution be included in the list of recognized institutions for 2010-2011 only. No admissions be made in the session 2011-12 until further decision of WRC.

Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants permission to Shri Jhulelal Science
