WITHDRAWAL ORDER

WHEREAS recognition/permission was granted, **ARYAN COLLEGE OF EDUCATION, BHOOTESHWAR ROAD, LAXMAN TALLIYA, SHINDE KI CHIAWANI, LASHIKAR,, GWALIOR, MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting **B.ED** course for the academic session **2005-2006** with an annual intake of **100** student, vide WRC order No.WRC/2-32/223387/74/2005/4943 dated **27.06.2005**.

2. AND WHEREAS, on the basis of complaint received against institution, the Western Regional Committee has constituted a visiting team u/s 17 of NCTE Act, 1993 to visit the institution.

3. AND WHEREAS, the inspection of **ARYAN COLLEGE OF EDUCATION, BHOOTESHWAR ROAD, LAXMAN TALLIYA, SHINDE KI CHIAWANI, LASHIKAR,, GWALIOR, MADHYA PRADESH** was conducted under section 17 on dtd. **20.11.2009**.

4. AND WHEREAS, the matter was considered by the WRC in its **128<sup>th</sup>** meeting and WRC noted that the following deficiencies exist vis-à-vis NCTE norms:-

- i) *That the institution has contravened sub-clause (13) of clause 8 of the NCTE Regulations 2007.*
- ii) *That the institution has contravened sub-clause (11) of clause 8 of the NCTE Regulation 2007.*
- iii) *That the institution has contravened clause 5.1.1 of Appendix 4 of the NCTE Regulations 2007.*
- iv) *That the institution has contravened clause 4.1 of Appendix 4 of the NCTE Regulations 2007.*

5. AND WHEREAS the WRC directed that an opportunity be given the institution to make a written representation within **14** days from the date of the letter before withdrawal of recognition as per provisions contained under section 17 of the NCTE Act, on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on **28.12.2009**.

5. AND WHEREAS the matter was again considered by the Committee in its 130<sup>th</sup> meeting held on **Jan,22-23,2010** and having taken into consideration all the relevant facts of the case, it was decided to withdrawn recognition for conducting **B.ED.** course on the following grounds:-

i). *The institution neither submitted the document mentioned in the show cause notice nor give plausible explanation in respect of grounds (i) & (iv) of the show cause notice .*

6. NOW, therefore, recognition **ARYAN COLLEGE OF EDUCATION, BHOOTESHWAR ROAD, LAXMAN TALLIYA, SHINDE KI CHHAWANI, LASHKAR,, GWALIOR, MADHYA PRADESH** for **B.ED** course vide order No.**WRC/2-32/223387/74/2005/4943** dated **27.06.2005** is hereby withdrawn in terms of Section 17(1) of the NCTE Act, 1993, on the above mentioned grounds from the end of the academic session next following the date of this withdrawal order.

7. Affiliating Body is advised not to admit/ allot any student in **B.ED.** Course in the said institute for the session specified in above para .

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days. The guidelines of appeal are enclosed herewith.
