Order

Whereas, recognition was granted to **ARYAN COLLEGE OF EDUCATION, BHOOTESHWAR ROAD, LAXMAN TALLIYA, SHINDE KE CHHAWANI, LASHKAR, GWALIOR, M.P.** under section 14 (3) (a) of NCTE Act, 1993 for conducting B.Ed. Course vide **order No. WRC/2-32/223387/74/2005/4943 dated 27/6/2005** from the academic session 2005-2006 with an annual intake of 100 students.

And whereas, the recognition of B.Ed. course of the institution was withdrawn by WRC in its 130 meeting vide order No. WRC/APW01893/223387/130/2010/66170-66176 dated 24/3/2010.

And whereas, the institution has preferred an appeal to Appellate authority of NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the said withdrawal order dated 24/3/2010.

And whereas, appellate authority passed an order No. F.No.89-502/2010/Appeal A-23091 dated 23/8/2010 in the appeal filed by the institution the appeal was rejected and WRC's order dated 24/3/2010 was confirmed.

And whereas, the institution has filed W.P. No. 7489/2010 in the High Court of M.P. Bench at Gwalior. The Hon'ble High Court passed order dated 14/3/2010 " (i) Petitioner has filed this petition for issuance of a direction to respondent No. 2 to include name of the petitioner institution in the list Annexure P-1 as recognized institution for admission of students in B.Ed. course for academic session 2010-2011. (ii) For the reasons stated in detail in the order passed in W.P. No. 7549/2010, Subhash Chandra Bose College, Gwalior Vs The NCTE and others, the petition of the petitioner is allowed. The respondents are directed to include name of the petitioner institution for admission of students of B.Ed. course for the academic session 2010-2011. However, this order is subject to order passed by the WRC on remand. Looking to the facts of the case, there shall be no order as to costs".

And whereas, the Court order was placed in WRC in its 148th meeting held on 10th to 12th April 2011 and committee decided that recognition restored for the session 2010-2011 only.

Now therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby permission granted to **ARYAN COLLEGE OF EDUCATION, BHOOTESHWAR ROAD, LAXMAN TALLIYA, SHINDE KE CHHAWANI, LASHKAR, GWALIOR, M.P.** for conducting **B.Ed. Course** of one year duration for the academic session 2010-2011 only with and annual intake of 100.
