ORDER

WHEREAS, recognition was granted to the institution, namely, ARYAN COLLEGE OF EDUCATION, PLOT/KHASRA NO - 1291/MIN2, VILLAGE - GRAM DHANELI, P.O - MORAR, GWALIOR-474006, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course (100 Intake) vide order dated 10.04.2007.

2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 05-01-2015.

3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, a Show cause notice was issued to the institution on 30.08.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 29.09.2016. The matter was placed in 285th Meeting of WRC held on December 19-21, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 30.08.2016, the institution has not submitted approved staff profile.

Building Completion Certificate not submitted.

FDRs of Rs.12.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn. FDRs if any, be returned."

7. AND, WHEREAS, the letter of Seeking Clarification was issued to the institution on 08.01.2018 and the institution filed W.P. No. 6770/2018 & 4815/2018, A E-Mail received on 10th July. The institution filed an appeal at NCTE, Hqrs. And appeal order dated 13.08.2018 confirmed the Order appealed against.

8. AND WHEREAS, the matter was placed in 296th Meeting held on August 28 - 29, 2019 of WRC and the Committee decided that "...This is a case of appeal as well as of the Hon'ble High Court of Delhi. Subsequent to the issue of the decision of High Court, the Appeal Committee vide order dated 13.08.2018 has confirmed the decision of WRC for withdrawal of recognition.

Hence, the Withdrawal Order dated 08.01.2018 stands.

9. AND, WHEREAS, the withdrawal order stands was issued to the institution on 04.09.2018 and filed an appeal again at NCTE, Hqrs. The appeal order dated 31.10.2018 was received on 12.11.2018, hereby remands back the case to the WRC, NCTE, for necessary action. The letter was received from the institution on 02.11.2018 with Court Order of Hon'ble High Court of Delhi at Delhi.

10. AND WHEREAS, the matter was placed in 301st Meeting held on January 17-18, 2019 of WRC and the Committee decided that "...This is a case of appeal. The Appellate Authority vide order dated 31.10.2018 has remanded the case to WRC.

The institution vide reply dated 02.11.2018 has submitted coloured photocopy of staff profile of 1+15 faculty members. Building Completion Certificate has been submitted.

Institution vide letter dated 29.11.2018 has requested to issue NOC for getting duplicate FDRs. The WRO is directed to issue required NOC.

The institution is required to submit the staff profile approved by the affiliating body in original.

Hence, Compliance be submitted by the institution within one month."

11. AND, WHEREAS, the letter of Seeking Clarification was issued to the institution on 25.01.2019 and the many reply was received from the institution with Court Order of Hon'ble High Court of Delhi at New Delhi dated 15.04.2018 W.P. No.(C) 6770/2018 with a direction to the respondents to upload and display the name and updated recognition status of the petitioner on its website for the academic year 2019-20 within three days.

12. AND WHEREAS, the matter was placed in 307th Meeting held on May 30-31, 2019 of WRC and the Committee decided that "...In view of the direction of the Hon'ble High Court of Delhi in CM No. 17793/2019, 17794/2019 in W.P. (C) 6770/2018 order dated 15/04/2019 and the committee considered the case of the institution and observed the following:

- FDRs No. 481462 is handwritten and be sent for validation.
- The institution has submitted photocopy of the staff profile for the session 2019-2020 in which the session mentioned is handwritten.
- The institution is required to submit latest staff list approved by the affiliating body alongwith the letter of granting approval of staff.

Hence, the committee decided to confer last opportunity to the institution to submit the above within 30 days failing which recognition will be withdrawn under section 17 of NCTE Act, 1993."

13. AND, WHEREAS, the letter of Seeking Clarification was issued to the institution on 06.06.2019 and reply was received from the institution on 24.06.2019 & 08.07.2019.

14. AND WHEREAS, the matter was placed in 310th Meeting held on August 19th-21st, 2019 of WRC and the Committee decided that "...The clarification letter was issued to the institution vide letter dated 06/06/2019 and reply received on 24/06/2019.

- The institution has submitted staff list of 1+15 faculty members approved by the affiliating body in original along with the letter of approval, FDRs Rs. 5+7 lakhs.

Hence, the committee decided to restore the recognition of two basic units of B.Ed. programme (total 100 students)."

15. NOW THEREFORE, the recognition of ARYAN COLLEGE OF EDUCATION, PLOT/KHASRA NO - 1291/MIN2, VILLAGE - GRAM DHANELI, P.O - MORAR, GWALIOR- 474006, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is hereby revived.
