RESTORATION ORDER

WHEREAS recognition was granted for B.P.Ed. programme of one year duration with annual intake of 50 students from the academic session 2015-2016 to the institution namely "Shri V.J. Patel College of Physical Education, C/o Mahatama Gandhi Vidhayalaya Campus, Mogri Anand Gujarat - 388345" vide Order No. WRC/5-6/89th/2006/C-11728 dated 27.09.2007/03.03.2007.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, Revised Recognition Order was issued vide F.No.WRC/APW02103/324064/2015/148753-760 dated 31.05.2015 for B.P.Ed. Programme of two years duration with an annual intake, of 100 students (One basic unit of 100 students) from the academic session 2015-2016 to the institution namely "Shri V.J. Patel College of Physical Education, C/O Mahatama Gandhi Vidhayalaya Campus, Mogri Anand, Gujarat - 388345".

3. **AND WHEREAS**, the matter regarding non-submission of PAR by the institution for the academic session 2022-23 was considered by WRC in its 416th meeting held on 20th March, 2025 and as per decision of the Committee, Show Cause Notice under Section 17(1) of NCTE Act, 1993 vide letter dated 12.04.2025 was issued to the institution.

4. **AND WHEREAS**, the matter was considered by WRC in its 424th meeting held on 20th May, 2025 and the Committee decided that the recognition/permission granted to SHRI V.J. PATEL COLLEGE OF PHYSICAL EDUCATION as referred above be withdrawn under Section 17 of NCTE Act, 1-993 on the grounds/reasons mentioned therein with effect from the academic session 2025-2026. Accordingly, withdrawal order vide order No. NCTE/2025IWRC/PAR/ORDER/APW 02103/324064/6200-6205 dated 24.05.2025 was issued to the institution.

5. **AND WHEREAS**, the institution has submitted letters dated 22.07.2025 and 23.07.2025 reply with clarification status that "Our institution has already submitted the PAR bearing no. P-2223033415 for the session 2022-2023 within the stipulated time as per NCTE Norms" with supporting documents.

6. **AND WHEREAS**, the institution filed an appeal against the WRC withdrawal Order dated 24.05.2025 before the Appellate Authority and NCTE Appellate Authority passed vide order dated 13.01.2026 remanding back the matter to WRC for fresh consideration as mentioned therein, details below: -

"...After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the impugned order dated 24.05.2025 and remand back the case to Western Regional Committee for fresh consideration strictly in accordance with the directions contained hereinabove, the applicable law, and the binding decision of the General Body of the Council. The appellant institution is further directed to forward to the Regional Committee, within fifteen (15) days of receipt of this order, the documents submitted along with the appeal, whereupon the Regional Committee shall take further necessary action strictly in accordance with law and in light of the directions contained herein."

7. **AND WHEREAS**, the matter was considered by WRC in its 458 (Part-I-A) meeting held on 27th – 30th April, 2026 and the Committee decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations, directions of the Hon'ble Court, Guidelines issued by NCTE from time to time were carefully considered by the WRC, NCTE and the Committee observed as under:

1. *The recognition of the institution was withdrawal by WRC vide order No. NCTE/2025/PAR/ORDER/APW02103/324064/6200-6205 dated 24.05.2025 regarding institution has not submitted any reply against the show cause notice within 15 days from issue of notice.*

2. *Thereafter, institution filed an appeal before the Appellate Authority at NCTE, New Delhi and the Appellate Authority vide order dated 13.01.2026 has remanded back the case to WRC for fresh consideration strictly in accordance with the directions contained hereinabove, the applicable law, and the binding decision of the General Body of the Council.*

3. *The institution again submitted letter dated 09.04.2026 and 10.04.2026 enclosing the document showing that the institution has already filled the PAR bearing no. P2122020844 for the session 2021-2022 on 04.12.2024 and P-2223033415 for the session 2022-2023 online through PAR portal dated 09.12.2024 for the academic session 2022-23 i.e. well before the last date.*

In view of the above, the WRC decided that restoration order for B.P.Ed course with an annual intake of 100 students be issued to the institution."

8. **NOW THEREFORE**, in compliance of directions of Appeal Order, recognition for B.P.Ed. course with an annual intake of 100 students (One basic unit) with two Sections of 50 (Fifty) each in respect of institution viz. Shri V.J. Patel College of Physical Education, C/O Mahatama Gandhi Vidhayalaya Campus, pMogri Anand, Gujarat – 388345" is hereby restored.
