Withdrawal Order

Whereas, the recognition was granted to the institution namely **RIDDHI EDUCATION TRUST, HIMATNAGAR RIDDHI P.T.C. C, GADDHADA, 13, MOTIBAUG SOCIETY, MOTIPURA, HIMATNAGAR, SABARKANTHA (APW02902/322318)** for P.T.C. (Co-Ed.) Course vide order No. WRC/5-6/90/2006/ dated 28-10-2006.

And whereas, a Show Cause Notice under section 17 of the NCTE Act, 1993 was issued to the institution on 12.01.2012 inter-alia informing the institution about the provision of the regulations and compliance of shifting of the institution in its own premises from the rented premises where the recognition was granted.

And whereas, the written representation submitted by the institution on 30.01.2013, and the matter was placed before the WRC in its 174th Meeting held on 19th - 21st, Nov. 2012, and the Committee decided to clarification letter be issued, accordingly clarification letter issued to the institution on 18.12.2012.

And whereas, the reply submitted by the institution on 02.01.2013, and the matter was placed before WRC in its 184th meeting held on May 27-29, 2013, and the Committee decided to withdraw the recognition on the following grounds:-

"A Show Cause Notice u/s 17(1) of the NCTE Act, 1993 was issued to the institution on 12.01.2012, in which it was informed that as per the NCTE Regulations, it was given recognition for PTC (Co-Ed) course in rented building, but as per the Regulations, after three years the institution should have shifted to own building. The institution replied vide its letter dated 25.01.2012 that a PTC college building has been constructed in the year 2007 and it had shifted in that building in 2009. The institution also submitted some documents and also requested for grant of transfer from rented building to ownership building. These documents were seen in the 174th meeting and it was found that the institution had not even submitted the application form for shifting, had not supplied the English version of the Gujarati land documents, CLU, building completion certificate, the building plan signed by the competent authority, the non-encumbrance certificate, the affidavits, and an amount of Rs.10,000/- being the difference between earlier fee of Rs.40,000/- and the present fee of Rs.50,000/-. Hence, letter dated 18.12.2012 was issued to the institution to obtain clarification on these points. Vide its reply dated 25.12.2012, the institution has submitted the application form alongwith Rs.1,000/-, the English version of notarized land documents, photocopy of the building completion certificate and affidavits. The examination of the documents shows the following lacunae:-

1. The land documents are notarized but not certified by the Registrar/Sub-Registrar which is the requirement;
2. The photocopy of the building completion certificate does not show that it is approved by the competent authority;
3. The building plan is not approved by the competent authority;
4. Non-encumbrance certificate has not been submitted;
5. Only photocopies of the affidavits are submitted, whereas they should be submitted in original; and
6. The DD of Rs.10,000/- has not been submitted.

The institution has been given sufficient opportunity to submit the documents which are required before shifting permission is given. Hence, there is no recourse other than to reject the request to shift the premises and Recognition is withdrawn from the end of the academic session next to the date of issue of withdrawal order."

Now therefore, in exercise of powers vested under section 17(1) of the NCTE Act, 1993, the recognition of **RIDDHI EDUCATION TRUST, HIMATNAGAR RIDDHI P.T.C. C, GADDHADA, 13, MOTIBAUG SOCIETY, MOTIPURA, HIMATNAGAR, SABARKANTHA** for P.T.C. (Co-Ed.) course is hereby withdrawn from the end of the academic session next following the date of the withdrawal order.
