ORDER

526, 527, 528, 529, 530, 531, 532

**WHEREAS**, WRC, NCTE had granted recognition/permission to M.B. KHALSA INSTITUTION OF EDUCATION, RAJMOHALLA SQUARE, SHAHID BHAGAT SINGH STATUE, NEAR GANGWAL BUS STAND, INDORE-452002, MADHYA PRADESH vide order dated 20.04.2004 & 01.03.2008 to start the B.ED. (CO-ED) course with an annual intake of 200 students.

**AND WHEREAS**, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015. The institution submitted affidavit vide letter dated 23.01.2015.

**AND WHEREAS**, Revised Recognition order was issued for four basic units of (50 students each) 200 students to the institution on 31.05.2015.

**AND WHEREAS**, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."

**AND, WHEREAS**, a Show cause notice was issued to institution on 08.08.2016 for not submitting compliance of Regulation 2014 required faculty staff list for four units and infrastructure and reply was received on 01.09.2016.

**AND WHEREAS**, the matter was placed in 284<sup>th</sup> Meeting of WRC held on November 28-29, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 08.08.2016, the institution has submitted a list of 1+9 faculty members. Out of which, faculty at S.No.6 does not have 55% in PG. The staff profile as per Appendix-IV of NCTE Regulations, 2014, approved by the affiliating body should be submitted in original.

Secondly, Building Completion Certificate signed by a Govt. Engineer and remaining FDR of Rs.4.00 lakhs (in joint name) should be submitted in original.

**Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn.**

**AND WHEREAS**, a clarification letter was issued to the institution on 01.12.2017 and reply was received on 24.01.2018.

**AND WHEREAS**, the matter was placed in 290<sup>th</sup> Meeting of WRC held on March 21-23, 2018 and the Committee decided that "...Consequent to the Show Cause Notice, Compliance letter was issued to the institution on 01.12.2017. The institution replied on 24.01.2018. The institution has submitted a Building Completion Certificate from Municipal Corporation, Indore. There is a staff profile of 1+8 excluding lecturer at S.No.6 (who should not be appointed) which is sufficient for one unit.

**Hence, permitted to continue with one unit after reducing the intake from four units to one unit."**
