ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to M.B. KHALSA INSTITUTION OF EDUCATION, RAJMOHALLA SQUARE, SHAHID BHAGAT SINGH STATUE NEAR GANGWAL BUS STAND, INDORE 452002 MADHYA PRADESH vide order dated 01.03.2008 to start the B.ED. course with an annual intake of 100 students.

2. AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015. The institution submitted affidavit vide letter dated 23.01.2015.

3. AND WHEREAS, Revised Recognition order was issued four basic units (200 students each) to the institution on 31.05.2015.

4. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, the Compliance Show Cause Notice was issued to the institution on 08.08.2016 and the reply of Show Cause Notice was received on 01.09.2016.

6. AND WHEREAS, the matter was placed in 284th Meeting of WRC held on November 28-29, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 08.08.2016, the institution has submitted a list of 1+9 faculty members. Out of which, faculty at S.No.6 does not have 55% in PG. The staff profile as per Appendix-IV of NCTE Regulations, 2014, approved by the affiliating body should be submitted in original.

Secondly, Building Completion Certificate signed by a Govt. Engineer and remaining FDR of Rs.4.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

7. AND, WHEREAS, a clarification letter was issued to the institution on 01.12.2017 and reply was received on 24.01.2018.

8. AND, WHEREAS, the matter was placed in 290th Meeting of WRC held on March 21-23, 2018 and the Committee decided that "... Consequent to the Show Cause Notice, Compliance letter was issued to the institution on 01.12.2017. The institution replied on 24.01.2018. The institution has submitted a Building Completion Certificate from Municipal Corporation, Indore. There is a staff profile of 1+8 excluding lecturer at S.No.6 (who should not be appointed) which is sufficient for one unit.

Hence, permitted to continue with one unit after reducing the intake from four units to one unit."

9. AND WHEREAS, order of reduced intake was issued by the WRC on 28.03.2018.

10. AND WHEREAS, an appeal was filed by the institution u/s-18 of the NCTE Act, 1993 Appeal dated on 21.05.2018.

11. AND WHEREAS, the appeal order dated 12-09-2018, After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the WRC with a direction to consider the staff profile for B.Ed. course, to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the WRC, the staff profile submitted in appeal, within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

NOW THEREFORE, the Council hereby remands back the case of M.B. Khalsa Institution of Education, Rajmohalla Square, Shahid Bhagat Singh Statue Indore, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

12. AND WHEREAS, the matter was placed in 299th Meeting held on October 30th – 31st November 01st 2018 of WRC and the Committee decided that "...This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC with a direction to consider the staff profile for B.Ed. course, to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014.

On perusal of the reply dated 20.09.2018, the Committee observed that:-

- (i) The institution has submitted the approved staff list of 1+33 faculty members for four basic units.
- (ii) FDR for Rs.12.00 lakhs in original as required under clause 10(1) of NCTE Regulations, 2014 submitted.

Hence, the Committee decided that Recognition of the institution be restored for four units of B.Ed. course."

13. NOW THEREFORE, the recognition of M.B. KHALSA INSTITUTION OF EDUCATION, RAJMOHALLA SQUARE, SHAHID BHAGAT SINGH STATUE NEAR GANGWAL BUS STAND, INDORE 452002 MADHYA PRADESH for conducting B.Ed. course with an annual intake of 200 students (four basic units of 50 students each) is hereby restored.
