SHIFTING ORDER

AND WHEREAS, the inspection of the new premises was conducted on 26.02.2016.

AND WHEREAS, the visiting team report alongwith other documents, videograph was placed before the WRC in its 248<sup>th</sup> Meeting of WRC held on April 11-12, 2016 and the Committee decided that "...The case file was seen. The report of the VT was perused and the CD was viewed. On perusal of the CD, it has been found that the institution has the required facilities. The VT has recommended the case.
